3. **L15-442 - East Feliciana Parish, Village of Wilson** - Not exceeding \$127,000 Waterworks Utility Revenue Certificates of Indebtedness, Series 2016, not exceeding 3.791%, not exceeding 7 years, improvements to the system, including installation of a new potable water well, chlorination facility and related equipment.
4. **L16-109 - Washington Parish, City of Bogalusa** - Not exceeding \$950,000 Revenue Anticipation Notes, Series 2016, not exceeding 6%, mature no later than March 1, 2017, current expenses.
5. **L16-130 - West Carroll Parish Police Jury** - Not exceeding \$1,534,000 Letter of Credit, not exceeding 4%, not exceeding 1 year, (1) satisfying DEQ's financial assurance requirements for the payment of closure costs for the landfill and (2) incur debt to the extent funds are drawn from the Letter of Credit.

8. **L16-106 - Calcasieu Parish, City of Lake Charles (DEQ Project)** - Not exceeding \$15,000,000 Sewer Revenue Notes, in one or more series, taxable or tax-exempt, not exceeding 4%, not exceeding 22 years, construct, acquire, extend or improve any work of public improvement, including but not limited to its Sewer System, including such treatment facilities as may be required, with all necessary equipment and installations.
9. **L16-115 - Calcasieu Parish School Board, School District No. 25** - Not exceeding \$10,000,000 General Obligation Refunding Bonds, Series 2016, not exceeding 5%, mature no later than July 15, 2033, refunding all or a portion of General Obligation Public School Improvement Bonds, Series 2013.
10. **L16-114 - Calcasieu Parish School Board, School District No. 33** - Not exceeding \$4,000,000 General Obligation Refunding Bonds, Series 2016, not exceeding 4.5%, mature no later than January 15, 2024, refunding 2020 through 2024 maturities of General Obligation Refunding Bonds, Series 2009.

11. **L16-116 - Calcasieu Parish School Board, School District No. 34** - Not exceeding \$4,000,000 General Obligation Refunding Bonds, Series 2016, not exceeding 4.5%, mature no later than January 15, 2024, refunding 2020 through 2024 maturities of General Obligation Refunding Bonds, Series 2009.
12. **L16-107 - Calcasieu Parish, West Calcasieu Port** - Not exceeding \$5,000,000 Revenue Bonds, taxable or tax-exempt, in one or more series, not exceeding 5%, not exceeding 20 years, improving existing waterfront property along the Gulf Intracoastal Waterway, including (1) construction and improvements to existing bulkhead areas; (2) construction of new bulkhead areas; (3) construction of roads and (4) maintenance dredging of barge slips and fleeting facilities.
13. **L16-127 - Caldwell Parish School Board, Consolidated School District No. 1** - Not exceeding \$9,000,000 General Obligation School Refunding Bonds, in one or more series, not exceeding 5%, mature no later than March 1, 2029, refunding all or a portion of General Obligation School Bonds, Series 2008 and 2009.
14. **L16-119 - East Baton Rouge Parish, Central Community School Board, Central Community School System** - Not exceeding \$7,800,000 General Obligation School Refunding Bonds, not exceeding 5%, mature no later than March 1, 2029, refunding all or a portion of General Obligation School Bonds, Series 2009.
15. **L16-110 - East Baton Rouge Parish, East Baton Rouge Sewerage Commission (DEQ Project)** - Not exceeding \$15,000,000 Taxable Revenue Bonds, Series 2016A, not exceeding 0.95%, not exceeding 22 years, constructing and acquiring sewers and sewerage disposal works, including necessary sites, right-of-ways, machinery and equipment.
16. **L16-112 - East Baton Rouge Parish, Metropolitan Council of the Parish of East Baton Rouge and City of Baton Rouge** - (1) Not exceeding \$45,000,000 Public Improvement Sales Tax Revenue Refunding Bonds, Series 2016A-1, not exceeding 5%, not exceeding 22 years, (a) refunding Public Improvement Sales Tax Revenue Refunding Bonds, Series 2008A-2 and (b) funding a reserve fund, if required; (2) not exceeding \$1,630,000 Public Improvement Sales Tax Revenue Refunding Bonds, Series 2016A-2 (Taxable), not exceeding 5%, not exceeding 14 years, (a) refunding Public Improvement Sales Tax Revenue Bonds, Series 2005B (Taxable) and (b) funding a reserve fund, if required; (3) not exceeding \$5,100,000 Public Improvement Sales Tax Revenue Bonds, Series 2016A-3, not exceeding 5%, not exceeding 31 years, (a) improvements to the public parking garage located at the Baton Rouge Metropolitan Airport and (b) funding a reserve fund, if required.
17. **L16-121 - Iberia Parish, City of New Iberia** - Not exceeding \$10,000,000 Revenue Refunding Bonds, not exceeding 6%, mature no later than November 1, 2035, refunding all or a portion of LCDA Revenue Bonds Series 2009 and 2010C.
18. **L16-113 - Iberville Parish, Town of White Castle** - Not exceeding \$3,000,000 Revenue Refunding Bonds, in one or more series, not exceeding 5%, mature no later than August 1, 2033, (1) refunding Sales Tax Revenue Bonds, Series 2008 and (2) funding a reserve fund or paying the premium for a debt service reserve fund surety policy to the extent required.
19. **L16-129 - Jefferson Davis Parish Police Jury, Road Sales Tax District No. 1** - Not exceeding \$13,000,000 Sales Tax Refunding Bonds, in one or more series, not exceeding 6%, mature no later than February 1, 2027, refunding all or a portion Sales Tax Bonds, Series 2007 and 2008.
20. **L16-124 - Lafayette Parish, City of Youngsville** - Not exceeding \$1,700,000 Sales Tax Refunding Bonds, not exceeding 6%, mature no later than May 1, 2029, refunding all or a portion of Sales Tax Bonds, Series 2009.
