The Commission's purpose is to safeguard life and health of the citizens of Louisiana, the law governing the practice of Nationally Registered and State Licensed EMS Practitioners, Louisiana Revised Statutes of 1950, R.S. 40:1133 et seq., as re-enacted and amended, delegates to this Commission the responsibility to establish and publish standards of out-of-hospital practice; to regulate the scope of practice of Emergency Medical Services Practitioners, to discipline and regulate the practice of Emergency Medical Services Practitioners and to establish standards for education programs preparing individuals for out-of-hospital practice.*
