CERTIFICATION OF INABILITY TO ACHIEVE IN-PERSON QUORUM & NOTICE TO MEET THROUGH ELECTRONIC MEANS

Issued January 11, 2021

In order to address the COVID-19 pandemic, Governor John Bel Edwards took measures to protect the public and issued several proclamations pertaining the crowd sizes and public buildings. Due to the continuing state of emergency, the Governor issued Proclamation Number 75 allowing boards and commissions to meet via electronic means so long as the public could observe and offer input. Proclamation Number 210 extended the provisions to conduct meetings via electronic means from December 23, 2020 thru January 13, 2021. Based on the current state of COVID in the State of Louisiana, we anticipate the Governor will extend this order again on January 13th.

The mandates for physical distancing and public safety prevent the Louisiana Fire & Emergency Training Commission from meeting in person and with members of the public. As such, the Commission will conduct its special meeting on January 19, 2021 through electronic means.

The Louisiana Fire & Emergency Training Commission will post the agenda in advance of the meeting on the LSU Fire & Emergency Training Institute's website.
