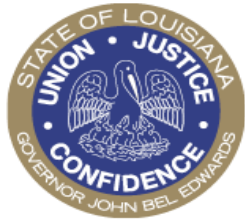

  - i. In January 2022, the Commission voted to adopt a guiding framework of prevention, identification, intervention, and prosecution to oversee its work this calendar year and voted to form four subcommittees to provide input and guidance in their respective subject areas.
