# STATE LICENSING BOARD FOR CONTRACTORS COMMERCIAL BOARD MEETING MINUTES NOVEMBER 21, 2013

No members were absent. Finding a quorum present, the regular order of business began.

Mr. Walker led the members and audience in the Pledge of Allegiance.

Judge Darrell White gave the invocation, introduced himself, and advised those present of his duties.

A motion was made to accept the Minutes of the October 17, 2013 regular meeting. The motion was seconded and passed unanimously.

Mr. McDuff introduced Kim Calloway, Rashida Keith, Sandy Painting, Nevonda Reed and Brandi Cannon with the Louisiana House of Representatives. Also present were Lynda Evans with the Capital Region Builders Association, Jeannie Dodd with the Louisiana Homebuilders Association, Ken Naquin with Associated General Contractors, John Walters with ABC, and Nick Castjohn of the LSLBC Residential Building Committee.

Mr. Jones gave a statement regarding Act 399 and the Office of Debt Recovery (ODR). Mr. Talbot made a motion to move forward with collecting debt through the Office of Debt Recovery, and Mr. Weston seconded. The motion passed.

#### C. JUDGMENT(S):

1. CRUZ CONSTRUCTION, LLC, Monroe, LA – La. R.S. 37:2150-2192, Sec. 2158(A)(9).

Ms. Dupuy gave a summary of the allegations. Edwin Cruz was present and sworn in. Mr. Cruz gave a statement to the Board. The judgment was filed and admitted into evidence. Mr. Talbot made a motion to allow Cruz Construction, LLC 60 days to resolve the unpaid judgment or the license will be revoked. Mr. Gallo seconded, and the motion passed.

Attorney Philip Ciaccia, Jr. was present on behalf of the creditor. Mr. Mitchell was sworn in, and each party gave a statement. The judgments were filed and admitted. Mr. Weston made a motion to allow ELEVATION MASTERS, INC. until February 1, 2014, to resolve the unpaid judgment or the license will be revoked. Mr. Meredith seconded, and the motion passed.

Ms. Dupuy gave a summary of the allegations. Robley Taylor was present on behalf of ROBLEY DEL TAYLOR. Creditors Phyllis and Richard Watson and their attorney Anne Watson were also present. All parties were sworn in and each gave a statement. Mr. Talbot made a motion to allow

ROBLEY DEL TAYLOR 30 days to resolve the unpaid judgment or the license will be revoked. Mr. Gallo seconded, and the motion passed.

Ms. Dupuy gave a summary of the allegations. Mr. Jones recused himself. Nathan Songy was present and sworn in. Four judgments were filed and admitted into evidence. Mr. Songy gave a statement. Mr. Talbot made a motion to revoke the license of SONGY AND SONS ENTERPRISE, LLC, and Mr. Weston seconded. The motion passed.

Ms. Dupuy gave a summary of the allegations. Thomas Lofton was present and sworn in. The judgment was filed and admitted. Mr. Lofton gave a statement. Mr. Meredith made a motion to allow Thomas Raymond Lofton 30 days to resolve the unpaid judgment or the license will be revoked. Mr. Dupuy seconded, and the motion passed.

Mr. Rawls gave a summary of the allegations and read the settlement offer presented by DAVID DEWAIN DUKE, who did not have a representative present. Mr. Dupuy made a motion to accept the settlement offer as presented, and Mr. Clouatre seconded. The motion passed.

Mr. Rawls gave a summary of the allegations and read the settlement offer presented by JOSE MARIO TERAN, who did not have a representative present. Mr. Clouatre made a motion to accept the settlement offer as presented, and Mr. Walker seconded. The motion passed.

Mr. Rawls gave a summary of the allegations. Attorney John Madison was present on behalf of Van Tassel-Proctor, Inc., and made a settlement offer. Mr. Clouatre made a motion to accept the settlement offer as presented, and Mr. Meredith seconded. The motion passed.

#### b) **INDUSTRIAL ROOFING, INC.,** Spiro, Oklahoma – La. R.S. 37:2160(A)(1).

Mr. Rawls gave a summary of the allegations. No one was present on behalf of INDUSTRIAL ROOFING, INC. Investigator Jessie Wells was called to the stand and sworn in for review of the exhibits. The complete exhibit packet was filed and admitted into evidence. Mr. Dupuy made a motion to find INDUSTRIAL ROOFING, INC. to be in violation, and Mr. Graham seconded. The motion passed. Mr. Dupuy made a motion to fine INDUSTRIAL ROOFING, INC. the maximum fine plus administrative costs, and Mr. Graham seconded. The motion passed with Mr. Badeaux's objection. After discussion, Mr. Weston made a motion to rescind Mr. Dupuy's penalty motion, and Mr. Fenet seconded. The motion passed. Mr. Meredith made a motion to fine INDUSTRIAL ROOFING, INC. \$2,500 plus administrative costs, reduced to \$1,000 plus administrative costs if licensed within 90 days. Mr. Fenet seconded, and the motion passed.

# c) <u>DWAYNE BENTON D/B/A BENTON CONSTRUCTION CO. LLC.</u> Beebe, Arkansas – La. R.S. 37:2160(A)(1).

Mr. Rawls gave a summary of the allegations. No one was present on behalf of DWAYNE BENTON D/B/A BENTON CONSTRUCTION CO. LLC. Investigator Jessie Wells was called to the stand and sworn in for review of the exhibits. The complete exhibit packet was filed and admitted into evidence. Mr. Fenet made a motion to find DWAYNE BENTON D/B/A BENTON CONSTRUCTION CO. LLC to be in violation and fine \$2,500 plus administrative costs, reduced to \$1,000 plus costs if licensed within 90 days. Mr. Clouatre seconded, and the motion passed.

#### d) Exco, INC., West Monroe, Louisiana – La. R.S. 37:2160(A)(1).

Mr. Rawls gave a summary of the allegations and read the settlement offer presented by EXCO, INC., which did not have a representative present. Mr. Clouatre made a motion to accept the settlement offer as presented, and Mr. Gallo seconded. The motion passed.
