# STATE LICENSING BOARD FOR CONTRACTORS COMMERCIAL BOARD MEETING MINUTES

Mr. Cain gave a statement. Mr. Fenet made a motion to find FRED M CAIN D/B/A CAIN'S HEATING & AIR CONDITIONING to not be in violation. Mr. Lambert seconded. The motion passed with one objection.

Ms. Sims entered the exhibit packet into evidence and it was admitted. Mrs. Rodriguez gave a statement. Mrs. Rodriguez changed the plea to a no contest plea. Mr. Lambert made a motion to accept the plea. Mr. Jones seconded. The motion passed. Mr. Lambert made a motion to not fine HIGHWAY 63 COLLISION, LLC. Mr. Fenet seconded. The motion passed.

Mr. Stuart seconded. The motion passed. Mr. Dupuy made a motion to access the maximum fine plus \$500 administrative costs. Mr. Lambert seconded. The motion passed.

Ms. Hughes gave a summary of the allegations. Billy Burgess was present on behalf of BGB CONSTRUCTION, LLC and was sworn in. Mr. Burgess entered a no contest plea. Mr. Weston made a motion to accept the plea. Mr. Jones seconded. The motion passed. Mr. Weston made a motion to fine BGB CONSTRUCTION, LLC \$500 plus \$500 in administrative costs. Mr. Fenet seconded. The motion passed.

Ms. Hughes gave a summary of the allegations. Ronnie Foreman was present on behalf of BAYOU FIRE PROTECTION, INC and was sworn in. Mr. Foreman entered a no contest plea. Mr. Talbot made a motion to accept the plea. Mr. Jones seconded. The motion passed. Mr. Foreman gave a statement and presented a settlement offer of \$500 plus \$500 administrative costs. Mr. Lambert made a motion to accept the settlement offer. Mr. Graham seconded. The motion passed.
