# STATE LICENSING BOARD FOR CONTRACTORS COMMERCIAL BOARD

# **MEETING MINUTES**

July 20, 2017

The regular meeting of the Commercial Board was called to order by the Chairman, Lee Mallet, on Thursday, July 20, 2017 at 9:36 a.m. at 2525 Quail Drive, Baton Rouge, Louisiana.

Members Danny R. Graham, Jaclyn S. Hotard, and Christopher N. Stuart were absent. Finding a quorum present, the regular order of business began.

Also attending the meeting were: Michael B. McDuff, Executive Director; Judy Dupuy, Board Administrator; Judge Darrell White, Retired, Hearing Officer; Larry Bankston, Board Attorney; and from the staff, Leann Evans, Brent Templet, Lowana Cola, and John Dixon; Compliance Director, Brad Hassert; Compliance Investigators, Todd Brady, Frank Vaughn, Carl Bourque, and Johnny Rogers; and Tarah Revette recording the minutes.

Mr. Jones led the members and audience in the Pledge of Allegiance.

Judge Darrell White gave the invocation, introduced himself, and advised those present of his duties.

Mr. Lambert made a motion to accept the Minutes of the **June 15, 2017** regular meeting. Mr. Weston seconded. The motion passed.

Mr. Hassert asked Compliance Investigator Carl Bourque to come forward. Mr. Hassert recognized Mr. Bourque for his 13 years of service with LSLBC. Mr. Hassert also stated that Mr. Bourque will be retiring from the agency at the end of July. The Board thanked Mr. Bourque for his service to the agency and congratulated Mr. Bourque on his retirement.

#### **NEW BUSINESS**

- C. QUALIFYING PARTY HEARINGS La. R.S. 37:2156.1, Sec. 103 Rules and Regulations of the Board
  - 1. Ms. Dupuy gave a summary of the allegations. No one was present on behalf of CLYDE BERGEMANN US INC. Mr. Talbot made a motion to allow the company 30 days to replace the qualifying party and pass the required examinations and if the company fails to comply within the timeframe given the company's license will be automatically revoked by staff. Mr. Fenet seconded. The motion passed. Mr. Bankston entered the exhibit packet into evidence and it was admitted.

Ms. Dupuy gave a summary of the allegations. Attorney Henry King and Tim Kinyomi were present on behalf of BOKAS BUILDING DESIGNS, LLC. Mr. Kinyomi was sworn in. Dean Hooker, the creditor for this matter, was also present and was sworn in. Mr. Bankston addressed the board regarding this matter. Mr. Bankston entered the exhibit packet into evidence and it was admitted. Mr. Kinyomi gave a statement to the board. Ms. Hooker provided testimony to the board. Mr. Jones made a motion to give BOKAS BUILDING DESIGNS, LLC 30 days to pay the judgment or enter into a payment plan. If these terms are not satisfied within 30 days the license will be automatically revoked by staff. Mr. Gallo seconded. The motion passed. The payment was made in the presence of the Board by Mr. Kinyomi to Ms. Hooker.

Mr. White provided testimony to the board. If these terms are not satisfied within 60 days the license will be automatically revoked by staff. Mr. Weston seconded. The motion passed.

Leann Evans, Administrative Compliance Director, was sworn in.

1. a) A – Professional Heating & Air Conditioning, LLC, Hammond, Louisiana La. R.S. 37:2158(A)(4)

Ms. Evans gave a summary of the allegations and read the settlement offer presented by A – PROFESSIONAL HEATING & AIR CONDITIONING, LLC. Mr. Gallo made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Fenet seconded. The motion passed.

b) **ELITE CONSTRUCTION, INC.,** Lexington, Georgia – La. R.S. 37:2160(A)(1)

Ms. Evans gave a summary of the allegations. No one was present on behalf of ELITE CONSTRUCTION, INC. Investigator Frank Vaughn was called to the stand and was sworn in. Mr. Vaughn reviewed the exhibit packet and provided testimony to the board. Mr. Bankston entered the exhibit packet into evidence and it was admitted. Mr. Weston made a motion to find ELITE CONSTRUCTION, INC. to be in violation. Mr. Dupuy seconded. The motion passed. Mr. Weston made a motion to assess the maximum fine plus \$500 in administrative costs. Mr. Gallo seconded. The motion passed.

Ms. Evans gave a summary of the allegations and read the settlement offer presented by ROBERT WOLFE CONSTRUCTION, INC. Mr. Gallo made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Talbot seconded. The motion passed.

Ms. Evans gave a summary of the allegations and read the settlement offer presented by JUAN YANEZ D/B/A J. YANEZ CONSTRUCTION. Mr. Fenet made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Gallo seconded. The motion passed.

3. **Kenneth Genzasi Wang**, Baton Rouge, Louisiana – La. R.S. 37:2158(A)(3) and Rules and Regulations of the Board Sec. 109

Ms. Evans gave a summary of the allegations. KENNETH GENZASI WANG was present and was sworn in. Mr. Wang entered a no contest plea. Mr. Gallo made a motion to accept the plea. Mr. Dupuy seconded. The motion passed. Mr. Wang gave a statement. Mr. Gallo made a motion to access \$500 in administrative costs. Mr. Meredith seconded. The motion passed.

Ms. Evans gave a summary of the allegations and read the settlement offer presented by COMMERCIAL RENOVATION SERVICES, INC. Mr. Gallo made a motion to accept the settlement offer as presented, which included a no contest plea. Mr. Weston seconded. The motion passed.

Ms. Evans gave a summary of the allegations. C. DWAYNE ROSE was present and was sworn in. Paul Murphy was present on behalf of CIRQUE, INC. and was sworn in. Mr. Rose entered a denial plea. Mr. Meredith made a motion to accept the plea. Mr. Jones seconded. The motion passed. Mr. Murphy entered a no contest plea. Mr. Meredith made a motion to accept the plea. Mr. Jones seconded. The motion passed. Investigator Todd Brady was called to the stand and was sworn in. Mr. Brady reviewed the exhibit packet and provided testimony to the board. Mr. Bankston entered the exhibit packet into evidence and it was admitted. Mr. Murphy gave a statement to the board regarding these matters. Mr. Brady provided additional testimony to the board. Mr. Bankston addressed the Board. The board questioned Mr. Rose and Mr. Murphy. After discussion, Mr. Rose changed his initial denial plea to a no contest plea. Mr. Jones made a motion to accept the plea. Mr. Weston seconded. The motion passed. Mr. Weston made a motion to assess a \$1000 fine plus \$500 in administrative costs and one year probation for C. DWAYNE ROSE. Mr. Gallo seconded. The motion passed with one opposed from Mr. Fenet. Mr. Weston made a motion to assess a \$1000 fine plus \$500 in administrative costs for CIROUE, INC. Mr. Jones seconded. The motion passed.

Ms. Evans gave a summary of the allegations. Filiberto Puente was present on behalf of FILIBERTO PUENTE CONSTRUCTION and was sworn in. Mr. Puente entered a no contest plea. Mr. Jones made a motion to accept the plea. Mr. Meredith seconded. The motion passed. Mr. Puente gave a statement to the board. Mr. Talbot made a motion to assess a \$1000 fine plus \$500 in administrative costs and to allow the fine to be reduced to \$500 plus \$500 in administrative costs if the company obtains a proper license within 90 days. Mr. Fenet seconded. The motion passed.

Ms. Dupuy gave a summary of the violation and the board action taken on February 16, 2017. Ms. Dupuy stated that the company notified the board that the judgment was satisfied and the company is requesting reinstatement of their license. Willie Parms was present on behalf of PARMS CONSTRUCTION, LLC and was sworn in. Mr. Clouatre made a motion to reconsider the penalty. Mr. Talbot seconded. The motion passed. Mr. Talbot made a motion to have staff verify that the judgment has been satisfied and to reinstate the company's license if the judgment has been satisfied. Mr. Gallo seconded. The motion passed.
