

**MINUTES OF THE GRAND ISLE INDEPENDENT  
LEVEE BOARD OF COMMISSIONERS REGULAR MEETING  
TUESDAY, AUGUST 12, 2014  
11:00 A.M.**

The Grand Isle Independent Levee District met on Tuesday, August 12, 2014, at 11:00 a.m. in a regular meeting at the Grand Isle Multiplex Center with the following commissioners:

Present: 3 Commissioners – David Camardelle, Kelly Besson, Sr. and Arthur Bellanger

Absent: 0

President Camardelle called the meeting to order and then led with the Pledge of Allegiance, followed by a prayer.

A motion was made by Commissioner Bellanger, seconded by Commissioner Besson and unanimously agreed to approve the minutes of the meeting held on June 30, 2014 as read.

President Camardelle gave the following report: 1. The contractor started construction on the CIAP funded additional three breakwaters. These breakwaters are being constructed with money left over from the last breakwaters. The commissioners will meet later today and take a boat ride to observe the construction operation. 2. CB&I has completed about 30% of the design phase of the Capital Outlay Breakwaters and should be able to present to the commissioners for review. 3. CB& I is working on revising the existing permit for breakwaters to include adding a breakwater to protect the new Grand Isle Bridge.4. The company to cut the trees will be here next week and Commissioner Bellanger will oversee the job.

President Camardelle thanked Senator Landrieu, Senator Vitter and Representative Scalise for seeking money to help dredge Bayou Rigaud and use the spoils on Fifi Island to help protect Grand Isle. Mr. Camardelle also thanked Senator Alario, Representative Gisclair, Governor Jindal, CPRA staff for working to continue our segmented rock breakwaters. Mr. Camardelle thanked Jefferson Parish Officials, Town Officials and the Port Commissioners for working together to build more segmented rock breakwaters and dredge work on Bayou Rigaud.

A joint motion was made by the commissioners of the levee district to approve expenses associated with the commissioners and engineer going to Washington D.C. in September 2014 with the Lower Mississippi Valley Association to meet with the Louisiana Delegation on behalf of the levee district.

A motion was made by Commissioner Bellanger, seconded by Commissioner Besson and unanimously agreed to approve the expenses associated with operating the levee board.

A motion was made by Commissioner Besson, seconded by Commissioner Bellanger and unanimously agreed to adjourn the meeting at 11:48 a.m.
