#### VII. New Business

a. Approval of Applicants to be Credentialed

b. New Board Appointments:

c. New Secretary/Treasurer Nomination

d. SCR 65 of the 2016 Regular Legislative Session Discussion:

It was discussed that SCR 65 is a resolution that creates a task force to study meaningful oversight of professional healthcare licensing boards that are under the umbrella of DHH. Each board on the legislative list has been ask to designate a representative to serve on this task force.

A motion was made by Paul Schoen, LAC, CCGC, and seconded by Bernadine Williams, LAC, CCS to give Roy Baas, LAC, CCS, CCGC the authority to assign the individual to represent our board on the task force. The motion was approved after a unanimous vote in the affirmative.

e. Late Fee Waiver Request: Janine Jackson

Ms. Jackson's LAC expired on 12.31.15. The ADRA office received her renewal on 2.24.16. We ask 3 weeks for processing. During Ms. Jackson's 3 week processing period, we had 2.5 unexpected state office closures due to weather and another day was spent out for a board meeting. Ms. Jackson's LAC was renewed and updated 3 weeks and 3 days after we received it. Ms. Jackson requested that her late fee be refunded to her due to the delay in processing.

The board does not have the authority to waive fees outlined by law.

A motion was made by Bernadine Williams LAC, CCS and seconded by Paul Schoen LAC, CCGC to deny Ms. Jackson's request. The motion was approved after a unanimous vote in the affirmative.

f. Approval of Consent Agreement – Steve Nick

- b) SB 309 Update Marolon Mangham

Senate Bill 309 amends supervision requirements for Certified Addiction Counselors. The bill states that CAC's cannot practice independently except when providing addiction counseling services in a prison or other custodial environments.

The Bill is expected to pass without issue.

- X. Executive Director's Report: Lauren Lear, Executive Director
  - ADRA has a new employee by the name of Bilan Spears. She will be replacing Keisha as the new Administrative Assistant. Keisha has transitioned to the Assistant Director position.
  - June 30<sup>th</sup> marks a big renewal cycle for the office. Because this falls in the middle of our transition, there may be some delay in processing.
  - A staff meeting was held Tuesday May 17, 2016 to ensure everyone is prepared for the increased workload over the next 2-3 months.
