- 2. We award the marijuana pharmacy permit for Region 5 to Medicis, LLC.

Prior to the vote, Mr. Rabb solicited member discussion and public comments, but none were offered. The motion was adopted after a unanimous roll call vote in the affirmative.

Mr. Rabb returned the panel to open session and questioned the panel as to their decision. Ms. Melancon then moved,

Prior to the vote, Mr. Rabb solicited member discussion and public comments, but none were offered. The motion was adopted after a unanimous roll call vote in the affirmative.

Mr. Finalet indicated completion of the cases scheduled for that day. Mr. Rabb expressed his appreciation to Mr. LaCour for his recording services that day.
