Bacque welcomed everyone to the meeting and reviewed the agenda. He opened the floor for comments from the public and there were none.

## **Legal Counsel Report**

### Incidental Practice Task Force

Spaht reported that the Task Force met in late March and discussed alternate solutions to the proposed definition of incidental practice prepared by LAPELS. He stated that assignments had been made for members of the Task Force to prepare recommendations for consideration at the next meeting. He further reported that there was consensus regarding the development of a joint committee comprised of representatives from LSBAE and LAPELS to review cases where an individual may have crossed the line of incidental practice.

The Board reviewed LAPELS' proposed definition and provided feedback on modifications to present to the Task Force for consideration. Such modifications included the necessity to have a definition that included the incidental practice of architecture to engineering and the incidental practice of engineering to architecture.

#### Rulemaking

LAC 46:I: Chapter 11, §1109 Military Licensure

LAC 46:1: Chapter 23, §2303 Adoption and Amendment of Rules

LAC 46:1: Chapter 23, §2305 Declaratory Rulings

The Board reviewed final drafts of proposed changes to its rules related to Military Licensure and the Adoption and Amendment of Rules, and a proposed new rule addressing Declaratory Rulings. A minor modification was requested to LAC 46:I: Chapter 23, §2305 Declaratory Rulings.

Motion #1: Tumlin/LeBlanc: To approve the proposed changes to LAC 46:I: Chapter 11, §1109 Military Licensure and LAC 46:I: Chapter 23, §2303 Adoption and Amendment of Rules, and the proposed new rule identified as LAC 46:I: Chapter 23, §2305 Declaratory Rulings, and authorize the rulemaking process begin by submitting the Fiscal and Economic Impact Statements (FEIS) for these rules to the Legislative Fiscal Office for review and consideration. Passed. 7-0.

Spaht reported that following review and approval of the FEIS, the proposed rule changes and new rule would need to be submitted to the Occupational Licensing Review Commission for its consideration. Approval of the OLRC is required prior to the publishing of a Notice of Intent.

SCS Inquiry: Use of Title Architect Response (FYI)

Spaht shared a copy of the Board's response to State Civil Service regarding its inquiry related to the use of the title "architect" in job titles and role descriptions for individuals in the Office of Technology Services who hold positions in the information technology field. He also shared a copy of the Board's response to the request from the Attorney General's Office regarding its preparation of an opinion for State Civil Service related to this same issue.

### NOLA Proposed Ordinance 122

Spaht shared the draft response to NOLA's request for feedback regarding possible amendments to its Code to require pre- and post-construction surveys of city right of way infrastructure to ensure that any damage sustained to said infrastructure during a permitted construction job is noted and properly fixed before occupancy is permitted.

The Board reviewed the draft response, suggested a few modifications, and asked that the letter be released.

#### **Minutes**

The Board reviewed the minutes of the February 26, 2021 meeting.

Motion #2: Blitch/Tumlin: To approve the minutes of the February 26, 2021 meeting. Passed. 7-0.

### **CRC** Report

Case #2021-03 - Ducote reported on a professional architectural firm which practiced and/or offered to practice architecture with an expired license. The respondent had signed and returned the proposed consent order offered by the CRC. The proposed consent order contained the following sanctions:

- 1. Respondent to pay a fine of \$4,000 payable in eight installments and costs of \$316.98;
- 2. Suspension of the architect's license if a scheduled payment is missed until the full balance is paid;
- 3. Publication of this disciplinary action on the Board's website and a summary of this matter in the Board's newsletter identifying Respondent by name, and
- 4. Reporting this matter to NCARB Disciplinary Database identifying Respondent by name.

Motion #3: Tumlin/Brinson: To accept the consent order for Case #2021-03 and authorize staff and legal counsel to move forward in obtaining a judgment against the respondent in an attempt to collect the fine and costs. Passed 4-0, with CRC members abstaining.

After the motion was passed, the respondent was identified as RGD Architecture, Inc.

Ducote provided an update on current enforcement statistics noting that there were 10 open cases, 4 cases closed since the last meeting, 2 cases opened since the last meeting, and 13 pending cases.

Ducote then shared cumulative enforcement statistics for 2019 and 2020.

#### **Licenses Issued for Ratification**

Hillegas reported the following registrations had been issued since the last Board meeting:

- 7 initial architect licenses,
- 23 reciprocal architect licenses,
- 8 reinstatement architect licenses,
- 18 Architectural Firms (4 in-state; 14 out-of-state),
- 3 Architectural Firms reinstated (1 in-state; 2 out-of-state),
- 2 Professional Architectural Corporations reinstated (1 in-state; 1 out-of-state), and
- 2 Architectural Engineering Corporations (2 out-of-state)

Motion #4: Tumlin/Cardone: To approve the list of licenses and certificates of authority issued for the period February 22, 2021 through April 13, 2021. Passed. 7-0.

### **Executive Directors Report**

## February and March 2021 Financial Statements

Hillegas reported that as of March 31 revenue from licensure continued to exceed budget projections by approximately \$50K. This was due in part to conservative budgeting anticipating a drop in licensure due to COVID-19, as well as the 3-month extension for firm licensure renewals. She noted that firm renewals will begin in May; however, that revenue will be deferred to the FY22 books.

She reported that expenses continue to run below the projected budget, in part due to travel restrictions related to COVID, as well as increased efforts to tighten the belt. She informed the Board that due to her computer crashing there was an unanticipated expense which will result in an overspend on the Capitol Outlay budget of approximately \$2,500.

## NCARB Special Business Meeting and ABM

Hillegas reminded the Board that NCARB will be hosting a Virtual Special Business Meeting on May 12 at 2:00 p.m., and she encouraged Board members to attend. A resolution will be presented that amends the Bylaws to allow for remote voting during business meetings which requires a vote by the Board.

She then reported that the NCARB Annual Business Meeting will take place on June 24 - 26 in Los Angeles. Due to COVID-19 restrictions, this meeting will be a hybrid meeting where attendees can opt to participate in person or virtually. Bacque was identified as the voting delegate for both the Special Business Meeting as well as the Annual Business Meeting.
