Louisiana State Board of Architectural Examiners Meeting Minutes December 11, 2020 Via Zoom

Tumlin welcomed everyone to the meeting and reviewed the agenda. He opened the floor for comments from the public, and there were none.

Legal Counsel Report

Incidental Practice Task Force

Spaht reported that he spoke with LAPELS attorney in early October prior to the Incidental Practice Task Force meeting. Following the October meeting of the Incidental Practice Task Force, LAPELS reached out and indicated that they would like to continue working to address concerns raised in our response to their proposed changes to LAC 46:LXI.105. They also indicated that should the Board want to further pursue an AG Opinion surrounding the authority to impose restrictions on architects practicing engineering and vice versa, they would like to assist in drafting such request for an opinion.

The Board deliberated options moving forward noting that while they had opposed the proposed definition of incidental practice that LAPELS was seeking to move forward, no alternate solution had been offered for consideration. Further, the Board indicated that they would like to get clarity from AIA Louisiana on their position related to LAPELS proposed rulemaking. It was agreed that Blitch, Spaht and Hillegas should engage in further discussion with AIA Louisiana and then the Task Force regarding the development of an alternate solution.

Upcoming Rule Changes

<u>Military Licensure</u>: Spaht reported that legislation passed in the regular session of 2020 required the Board to update their rules related to Military Licensure. He and Hillegas were working on preparing a draft for Board consideration.

<u>Declaratory Rulings</u>: He further reported that he had recently become aware of LA R.S. 49:962 which is a state statute that requires state agencies adopt language in their rules providing for the filing and prompt disposition of petitions for declaratory orders and rulings. To remedy the deficiency in our rules, he and Hillegas reviewed language from other state agencies as well as language used by other boards in the Southern Conference of NCARB and are preparing a draft rule for board consideration.

<u>Review of Rules</u>: Spaht reported that he had also recently learned of a rule in the Administrative Procedures Act that required the Board to incorporate a provision in their Rules to allow members of the public or outside of the board to address repeal or amendment of our rules. He and Hillegas will be working on drafting proposed language for Board consideration.

Minutes

The Board reviewed the minutes of the September 11, 2020 meeting.

Motion #1: Brinson/Bacque: To approve the minutes of the September 11, 2020 meeting. Passed. 7-0.

Complaint Review Committee Report

LeBlanc and Ducote presented the report of the Complaint Review Committee ("CRC") consisting of LeBlanc, Singh and Blitch.

<u>**Case #2019-14</u>** - Ducote reported on a professional architecture firm which practiced and/or offered to practice architecture with an expired license. The respondent signed and returned the proposed consent order offered by the CRC. The proposed consent order contained the following sanctions:</u>

- 1. Respondent to pay a fine of \$2,000 and costs of \$209.13,
- 2. Publication of this disciplinary action on the Board's website and a summary of this matter in the Board's newsletter identifying Respondent by name, and
- 3. Reporting this matter to NCARB Disciplinary Database identifying Respondent by name.

Motion #2: LeBlanc/Bacque: To accept the consent order for Case #2019-14. **Passed 4-0**, with CRC members abstaining.

After the motion was passed, the Respondent was identified as Clifton James, LLC.

<u>Case #2019-20</u> - Ducote reported on a professional architect who (a) sealed, stamped, or permitted his seal to be affixed to drawings which were not prepared by him or under his responsible charge, (b) failed to meet the Board's Continuing Education requirements and (c) committed fraud, deceit, material misstatement, or perjury in applying for a renewal certificate with the Board. The respondent signed and returned the proposed consent order offered by the CRC. The proposed consent order contained the following sanctions:

- 1. License to be suspended for one year beginning today,
- 2. Cease and desist,
- 3. Return all seals and certificates,
- 4. License to be placed on probation for 1 year upon completion of suspension period beginning December 11, 2021,
- 5. Submit on a quarterly basis during probation a complete list and detailed list of projects of which he provided architectural services during the preceding quarter,
- 6. Submit within 5 day of request, all documents relating to any project on any of said quarterly lists of projects,
- 7. Immediate suspension of architect license, if during probation period, respondent fails to comply with any portion of the Consent Order, with suspension continuing until he so complies,
- 8. Respondent to pay a fine of \$6,750 and costs of \$2,110.41,
- 9. Earn, within 60 days 2 HSW CEHs and forward proof to the Board,

- 10. Publication of this disciplinary action on the Board's website and a summary of this matter in the Board's newsletter identifying Respondent by name, and
- 11. Reporting this matter to NCARB Disciplinary Database identifying Respondent by name.

After discussion, Cardone made the motion to modify the sanctions to include earning 24 additional HSW credit hours. The motion failed for lack of a second.

Motion #3: LeBlanc/Bacque: To accept the consent order for Case #2019-20. **Passed 4-0**, with CRC members abstaining.

After the motion was passed, the Respondent was identified as Clifton C. James, Architect.

<u>**Case #2020-04**</u> – Ducote reported on an unlicensed firm which practiced and/or offered to practice architecture without proper licensure. The respondent signed and returned the proposed consent order offered by the CRC. The proposed consent order contained the following sanctions:

- 1. Respondent to pay a fine of \$1,500 and costs of \$448.85,
- 2. Publication of this disciplinary action on the Board's website and a summary of this matter in the Board's newsletter identifying Respondent by name, and
- 3. Reporting this matter to NCARB Disciplinary Database identifying Respondent by name.

Motion #4 LeBlanc/Bacque: To accept the consent order for Case #2020-04. **Passed 4-0**, with CRC members abstaining.

After the motion was passed, the Respondent was identified as The Hill Firm, Inc.

Ducote provided an update on current enforcement statistics noting that there were 14 open cases, 3 cases which had been closed since the last meeting, 0 cases that had been opened since the last meeting, and 10 pending cases.

Continuing Education Committee

Hillegas provided an overview of the results of the 2019 Continuing Education Audit reporting that 168 licensees were randomly selected for the audit and that 160 records had been completed to date. She indicated that staff is following up on the remaining 8 licensees. She further reported that 96 of the records submitted were AIA transcripts, and 68 were self-reported documentation. The Continuing Education Committee met in November and reviewed several files with incomplete or questionable documentation.

During the audit, it was observed that some licensing boards grant HSW continuing education hours for reading their newsletters. The Board discussed the possibility of offering similar credit for those who read the LSBAE newsletter. After considerable discussion, it was determined to further research the development of a bank of questions for a jurisprudence type exam to be published in the newsletter.

Licenses Issued for Ratification

Hillegas reported the following registrations had been issued since the last Board meeting:

- 6 initial
- 33 reciprocal
- 28 reinstatement
- 15 Architectural Firm (5 in-state; 10 out-of-state)
- 1 Architectural Engineering Firm (out-of-state)

Motion #5: Bacque/LeBlanc: To approve the list of licenses and certificates of authority issued for the period September 5, 2020, through November 29, 2020. Passed. 7-0.

She reported that initial applications remain slow following the closure of Prometric Test centers last spring and NCARB's processing time for initial evaluations is currently running \sim 50 days. She further reported that they are piloting a program with Ohio and NC to expedite final review of initial applicants record upon completion of ARE and AXP and that both jurisdictions are pleased with the faster turnaround.

Executive Directors Report

August, September and October 2020 Financial Statements

Hillegas reported that Firm Revenue is at 87.68% for the year. She reminded the Board that the deadline to renew firm licenses was extended by 90 days until September 30 in response to the stay-at-home orders related to the COVID-19 pandemic. This will impact the amount of time the Board is collecting delinquent revenue for the fiscal year by 3 months. Currently this amounts to approximately \$10K in unrealized revenue. Total revenue to date is \$150k – right on target with budget.

Expenses are currently at \$175K, running below budget. She noted that staff had eliminated the rental of Pitney Bowes postage machine and transferred to Stamps.com which will result in a significant reduction of expenses. The elimination of travel to meetings also contributed to reduced expenses.

The current bottom line represents a \$33K deficit. She noted that revenues are picking up as we are about $5\frac{1}{2}$ weeks into renewals. That will show in future financial statements. She indicated that we are about $\frac{1}{2}$ way there with renewals, with 1,768 already renewed, and another 1,672 still outstanding. There are two additional renewal reminders scheduled to go out before the end of the month.

Business Name Waiver Request

Ducote reviewed a name waiver request received.

Motion #6: LeBlanc/Singh: That the Board approved the name waiver request from Architectural Building Solutions. **Passed 7-0.**

Candidate Concerns with ARE 5.0 Changes

Hillegas shared communications received from candidates regarding changes to the ARE which were necessary to implement Remote Proctoring. She reported that NCARB is aware of these concerns and has been addressing them with the candidate population since the announcement of Remote Proctoring. She reminded the Board that remote proctoring will launch on December 14.

San Francisco Institute of Architecture

LeBlanc shared information he received regarding an online school of architecture with "ties" to Louisiana. Hillegas reported that upon further research, the BArch and MArch programs they offer are NOT NAAB accredited. The school lists its admissions office at an address in Ruston, LA. The address has been identified as a "Pack and Mail" storefront in Ruston. Further research indicated that there appears to be no Louisiana licensed architects affiliated with the school. It was agreed that there does not currently appear to be any violations of the architects licensing law or rules with respect to this school.

CY 21 Committee Assignments

Bacque and Brinson reviewed assignments to committees for 2021. It was noted that while Mr. Tumlin's appointment is set to expire in January 2021, the 2020 committees will remain in place until Mr. Tumlin's replacement is identified.

Complaint Review Committee – Singh (Chair), Blitch, Tumlin replacement Continuing Education Committee – LeBlanc, Cardone, Brinson (January – July), Bacque (July – December)

Motion #7: Cardone/Blitch: To adjourn. Passed. 7-0.
