Louisiana State Board of Architectural Examiners Meeting Minutes June 4, 2021 Via Zoom

This meeting was held via zoom pursuant to JBE Proclamation 2021-94 and R.S. 42:17.1, the governor having declared a state of emergency for the State of Louisiana, and the nature of the emergency causing a meeting of the Board conducted pursuant to other provisions of the Open Meetings Law, R.S. 42:1 et seq., to be potentially detrimental to the health, safety, or welfare of the Board, staff, and the public.

The meeting was called to order by Bacque who certified that the matters to be considered by the Board will be limited to the matters listed on the agenda of the meeting, such matters being time sensitive and in the opinion of Brinson consideration of which should not be delayed. The members of the Board approved the consideration of the matters on the agenda, and only such matters, by unanimous vote.

Bacque welcomed everyone to the meeting, reviewed the agenda, and validated that matters under consideration for the meeting will be limited to those matters identified on the agenda. He opened the floor for comments from the public, and there were none.

Motion #1: Singh/LeBlanc: To validate that matters under consideration for this meeting will be limited to items listed on the agenda. Passed. 7-0.

Legal Counsel Report

Spaht provided an explanation of R.S. 42:17.1 which allows the Board to meet virtually during a public health state of emergency. He shared information related to the process we must follow to maintain compliance.

Incidental Practice Task Force

Spaht reported that the Task Force has not convened a meeting since it met in April. It is anticipated that AIA LA will be reaching out to establish a meeting schedule soon. The Board reviewed a clean copy of potential modifications to the draft definition that was discussed by the Board during the April 2020 meeting along with the draft definition which was published in the *Louisiana Register* by LAPELS in November 2019.

Rulemaking

Spaht reported that the three rules mentioned above have been submitted to the Legislative Fiscal Office for consideration. He hoped to receive approval from the LFO in time to get on the agenda for the next OLRC meeting which is scheduled for June 17 so that the Notices of Intent for each rule can be published in the Louisiana Register in July.

AG Opinion: Use of Title Architect Response (FYI)

Spaht reported that the Board had prepared feedback to the Attorney General's office regarding an inquiry for an opinion on the use of the title architect in position titles and role descriptions for the Office of Telecommunications Management information technology positions. He noted that the opinion, now rendered, references our recommendation to precede some of the recommended titles with the term "IT" to prevent confusion about the possible practice of architecture, and it also agreed with our assessment regarding confusion that may be perceived by the title Facility Architect. He further reported that State Civil Service will move forward with creation of job titles based on information outlined in this opinion.

HB398

Spaht reported that there proposed legislation was being considered that would establish a separate optional review process of rules and disciplinary actions. The bill states that participation in the program will ensure that participating boards and board members will avoid liability under federal antitrust laws. Discussion ensued regarding whether immunity is currently provided through the Occupational Licensing Review Commission. Discussion ensued regarding this proposed legislation and whether Board members are protected from federal antitrust laws. It was agreed that further inquiries would be made to determine what antitrust protections are being provided to the board and its members.

April 16, 2021 Meeting

The Board reviewed the minutes of the April 16, 2021 meeting.

Motion #2: LeBlanc/Blitch: To approve the minutes of the April 16, 2021 meeting. Passed. 6-0-1.

Complaint Review Committee Report

Singh and Ducote presented the report of the Complaint Review Committee ("CRC") consisting of Singh, Blitch, and LeBlanc.

<u>Case #2021-04</u> - Ducote reported on a limited liability company which had practiced and/or offered to practice architecture with an expired certification. The respondent signed and returned the proposed consent order offered by the CRC. The proposed consent order contained the following sanctions:

- 1. Respondent to pay a fine of \$4,500 and costs of \$490.60;
- 2. Publication of this disciplinary action on the Board's website and a summary of this matter in the Board's newsletter identifying Respondent by name, and
- 3. Reporting this matter to NCARB Disciplinary Database identifying Respondent by name.

Motion #3: Cardone/Brinson: To accept the consent order for Case #2021-04. **Passed 4-0,** with CRC members abstaining.

After the motion passed, the Respondent was identified as **Dalton Architects**, Inc.

<u>Case #2021-06</u> - Ducote reported on a limited liability company which had practiced and/or offered to practice architecture with an expired certification. The respondent signed and returned the proposed consent order offered by the CRC. The proposed consent order contained the following sanctions:

- 1. Respondent to pay a fine of \$1,500 and costs of \$373.49;
- 2. Publication of this disciplinary action on the Board's website and a summary of this matter in the Board's newsletter identifying Respondent by name, and
- 3. Reporting this matter to NCARB Disciplinary Database identifying Respondent by name.

Motion #4: Cardone/Brinson: To accept the consent order for Case #2021-06. **Passed 4-0**, with CRC members abstaining.

After the motion passed, the Respondent was identified as Architects Plus, L.L.C.

Ducote shared statistics on the number of open cases, cases closed since the April meeting, new cases opened since the April meeting, and the number of pending cases.

Continuing Education Committee Report

Hillegas reported that the continuing education audit of records for calendar year 2020 was launched on April 29. She reported that: **174 licensees** were randomly selected for the audit (63 in-state and 111 out-of-state). She noted that to date, no response had been received from **10 licensees** (6 in-state and 4 out-of-state). She further reported that per the guidelines established by the Board, staff was currently communicating with **14 licensees** requesting further information/documentation (6 in-state and 8 out-of-state). Of the 174 licensees who were sent audit notifications, 147 licensee records (48 in-state and 99 out-of-state) have been determined to be "Audit Complete," such having met the 12 HSW CEH requirement.

Following the guidelines, staff is reaching out to those individuals who have not yet responded and those who are required to provide further information or documentation. Staff will provide an update to the CE Committee once the deadlines to submit have passed, and a report to the Board will be provided at the September 2021 meeting.

Licenses Issued for Ratification

Hillegas reported the following registrations had been issued since the last Board meeting:

- 6 initial architect licenses.
- 34 reciprocal architect licenses,
- 20 reinstatement architect licenses,
- 7 Architectural Firms (1 in-state; 6 out-of-state),
- 3 Professional Architectural Corporations reinstated (0 in-state; 3 out-of-state), and
- 2 Architectural Engineering Corporations (2 out-of-state).

Total Individuals Licenses:

- 1,323 in-state
- 2.091 out-of-state
- 3.414 Total
- 40 in-state emeritus
- 49 out-of state emeritus, and
- 2 suspended.

Executive Directors Report

April 2021 Financial Statements

Hillegas reported that firm revenue is exceeding budget projections. She noted that we are currently in the renewal cycle and that revenue received will defer to FY22. Individual licensure revenue is above budget projections due in part to increased efforts to reach out to expired licensees prior to end of right of renewal period resulting in an increase in renewals and reinstatements.

She further reported that expenses are running below budget projections currently at 63% of budget expenditures.

Architect Selection Board

Hillegas shared applications which had been received for representatives from Districts 3, 4 and 5 to serve on the Architect Selection Board. She noted that efforts are underway to identify candidates for Districts 1 and 2.

Motion #6: Blitch/Singh: To accept the applications of Kristopher Palagi (District 3), Jeffery Michael Kudla (District 4) and Benton Patterson (District 5) for service on the Architect Selection Board for the period September 15, 2021 through September 14, 2022. **Passed. 7-0.**

NCARB 2021 Annual Business Meeting

The Board reviewed the agenda and resolutions which will be presented at the NCARB 2021 Annual Business Meeting in Los Angeles (and virtually) on June 24-26. It was noted that some members will be attending in person and some virtually. Bacque was identified as the Voting Delegate and he will be voting on resolutions and the national election on behalf of the Board.
