Previous Minutes from the 20 March 2018 MFA Board Meeting were approved.

The MFA 3-Person Fund Committee met on 21 March 2018 and approved 1 application totaling \$339.89 for assistance with the Entergy Bill of a disabled Veteran and his family. The Board met again on 27 March 2018 and approved an application for \$395.00 to assist a Veteran with his auto insurance.

Holly Talley discussed the balance of the MFA Fund Balance. The most recent S07 report from the treasury had not been received prior to the meeting. Balance numbers are based on LDVA Fiscal records.

1. ACHA0418 Board Action: Deny

- Board recommends encouraging Veteran to follow up with his local VAC to see if there is any further assistance/benefits he may be eligible for form the Federal VA.
- Application denied as stands because all bills submitted are current and have no delinquent balances.

2. HGRE0418

Board Action: Deny/Approve, based on certain conditions

- Board approved to assist up to \$3,000 if the taxes owed are for the Veterans primary residence and losing home would risk Veteran becoming homeless and if the application was updated by being signed/dated in all places. Holly Talley was to follow-up
- <u>NOTE</u>: Holly Talley followed up with Veteran immediately after the 24 Apr meeting. The taxes owed were for a vacant property, located next to the Veteran's home. This property is not his primary residence and taxes owed do not effect his current home/property. Based on the Board's instruction, the application was denied since this property was not the Veteran's primary residence.

3. IWIL0418

Application withdrawn by Veteran

- The Veteran received his back pay from the VA that had been wrongly deposited in someone else's account. The Veteran was not longer in need of assistance and could meet his current obligations. The Veteran withdrew his application for assistance.

4. GBER0418

Board Action: Deny

- Application was denied for lack of sufficient documentation for the need of a large 10x16 raised deck on the Veterans home. The amount requested was not supported by documents provided.

5. BWHI0318 (application tabled from 20 Mar)

Board Action: Refer back to Fund Committee

- Thomas Enright made the motion to approve up to \$2500 for the application, once the Veteran can show her actual portion owed of debt. Once this amount is shown by Veteran, it should be sent to the Fund committee for final approval.

6. MCOL0318 (application tabled from 20 Mar)

Board Action: Deny

Veteran did not provide additional requested documents, after multiple attempts were made. Therefor the Board voted to deny his application.
