Dr. Hebert moved to approve the agenda . Dr. Chenier seconded the motion. The motion was unanimously approved.

- 2. LSSP Early and Periodic Screening, Diagnostics and Treatment Health Services (EPSDT) Medicaid Services Manual (updated 2/12/2021). The Committee reviewed this document, discussed concerns related to the omission of LSSP's in the updated reimbursement schedule. Ms. Monic shared her correspondence with Mr. Brandon Wilks, LSPA President. Dr. Chenier agreed to follow up with LSPA and reinforce that they may use the Board Opinion related to reimbursements. Ms. Monic agreed to docket the discussion for the next regularly scheduled meeting of the Board of Directors of the LSBEP in the event the Board wanted to respond further to the matter.
