# Minutes of the Strategic Planning Meeting of the Louisiana State Board of Social Work Examiners October 22, 2022

The meeting was conducted at the Board office and streamed via video conference, and all interested parties were provided the information to join the meeting. Sheri Morris, Legal Counsel, Regina DeWitt, Administrative Assistant, Sara Banks, Licensing Analyst, and Emily DeAngelo, Administrator, were present for the meeting.

Jamie Barney conducted roll call. Board members present at the time of roll call included Ruth Weinzettle, LCSW, Hyacinth McKee, LCSW, Carla Moore, LMSW, Trinity George, RSW, Evan Bergeron, Esq., and Jamie Barney, LCSW.

Bora Sunseri, LCSW, was absent.

### Agenda

**Motion** was made by Trinity George, seconded by Ruth Weinzettle, and unanimously carried, to approve the agenda as presented.

<u>Public Comments</u> – a call for public comments was made with each agenda item that required a vote.

<u>Recusal v Abstain for Board Members</u> — brief explanation of the difference Sheri Morris explained that a recusal is to avoid a conflict of interest. The board member who recuses is prohibited from the discussion and vote on the matter. Abstention is a voluntary removal from the vote. A board member may abstain from a vote if they do not have enough information to vote.

#### Agilify update

Sheri Morris has submitted the proposed contract to Agilify.

ASWB testing procedure with board approval – follow up from last strategic planning meeting regarding clinical examination

**Motion** was made by Jamie Barney, seconded by Trinity George, and unanimously carried, to allow a LMSW to sit for the Clinical exam upon completing 75 hours of supervision in addition to being within 6 months of completing supervision effective January 1, 2023 should the LMSW make such a request.
