POST MEETING MINUTES

September 29, 2022

NEW BUSINESS

<u>POST Certification – Reinstatements</u>

Ms. Taylor Hill presented the requests for reinstatement of POST certifications for the following: Officer Paul Granpre (Xavier University Police Dept.) – Level 1, Sgt. Darrel Hickman (Natchitoches Police Dept.) – Level 1, Officer Jason Loyd (Boyce Police Dept.) – Level 2 & Level 3), Officer Cody Miller (Carencro Police Dept.) – Level 1, and Officer Cody Thibodaux (Patterson Police Dept.) – Level 1. Chief Bonner made a motion to approve the requests for reinstatements of these POST certifications. After some discussion, Sheriff Stassi seconded the motion and the motion passed.

Chief Bonner made a motion to approve the medical waiver, submitted by the agency head after the June POST Council meeting, for Mr. Hamilton's 2021 POST In-Service training deficiency. After some discussion, Mr. Dwight seconded the motion and the motion passed.

POST Certification Revocation Appeal Hearing – Malcolm Ledet (Oberlin Police Dept.)

Ms. Taylor Hill presented the revocation appeal request to the Council members. Sheriff Ard asked if Mr. Ledet, or a representative, was present and no answer was heard. Sheriff Stassi made a motion to deny the appeal request. After some discussion, Mr. Bergeron seconded the motion and the motion passed.

After some discussion, Lt. Davis seconded the motion and the motion passed.

POST In-Service Training Waiver Committee – New Member Appointment

Sheriff Ard nominated Sheriff Stassi to serve on the POST In-Service Training Waiver Committee. Mr. Bergeron made a motion to appoint Sheriff Stassi as the new committee member. After some discussion, Chief Bonner seconded the motion and the motion passed.

POST Administrative Rule – Notice of Intent – "Human Trafficking Training"
