The meeting of the Louisiana State Racing Commission (LSRC) was called to order by the Chairman on Wednesday, August 25, 2021 at 9:00 AM on the Zoom Conference Call. Roll call was taken; a quorum was present.

The Chairman states that the Commission will respond as quickly as possible if Louisiana Downs' existing ownership or new ownership, pending sale of the racetrack, petitions the Commission for approval to apply for a sports wagering license.
