# RULE FOR DISCUSSION/NOTICE OF INTENT AUGUST 19, 2019 COMMISSION MEETING

(The 60 Days Stewards List for horse with clenbuterol positive was originally discussed at the August 27, 2018 Commission Meeting. However, Commission wanted to look at what other states were doing and get feedback from Equine Medical Director and Lab before proceeding)

#### Title 35

#### HORSE RACING

#### Part I. General Provisions

# Chapter 15. Permitted Medications

#### §1506. Permitted Medications in Quarter Horses

- A. Any racehorse participating in a quarter horse race shall comply with the medication rules set forth herein, specifically chapter 15 and 17, however the following exception(s) shall apply:
  - 1. Clenbuterol is a prohibited substance in Quarter Horses and other breeds racing with Quarter Horses. There is no applicable withdrawal guideline for such horses.
- B. Any quarter horse reported positive for Clenbuterol by the LSU Equine Medical Surveillance Laboratory and following a written ruling by the Stewards shall be placed on the Stewards List and is not eligible to be entered in a race for a period of sixty days from the race date of the positive.
- C. Penalties assessed pursuant to Section B are in addition to any set forth in LAC.35.I:1797.
