La. R.S. 42:17.1 Certification

On March 11, 2020, in Executive Proclamation 25 JBE 2020, Governor John Bel Edwards declared a state of emergency for Louisiana due to COVID-19. The state of emergency was extended in subsequent Executive Proclamations with the most recent extension in 7 JBE 2022 on January 19, 2022. The state of emergency is a public health one and an in-person meeting of the Louisiana Rehabilitative Council (LRC) would be detrimental to the health, safety, or welfare of the public.

In accordance with Louisiana Revised Statute 42:17.1, the presiding officer of the Louisiana Rehabilitative Council (LRC), Melissa Bayham, hereby certifies that the agenda of the meeting is limited to 1) matters that, if they are delayed, will cause curtailment of vital public services or severe economic dislocation and hardship and 2) matters that are critical to continuation of business of the Louisiana Workforce Commission- Louisiana Rehabilitative Services and are not able to be postponed due to other deadlines that cannot be postponed or delayed.

As such, in accordance with Louisiana Revised Statute 42:17.1, the Louisiana Rehabilitation Council meeting on Thursday, January 27, 2022 at 8:15 AM will be held by video conference and in a manner that allows for observation and input by members of the public in accordance with the provisions in La. R.S. 42:17.1(C).
