IN ATTENDANCE

After determining a quorum was present, Board Chair Justin Gremillion called the meeting to order at 9:00am. The minutes of the November 16, 2020 meeting were disseminated to members prior to the meeting; motion made by Chasity Cheramie to accept the minutes, seconded by Justin Gremillion --minutes were approved. The Report of the Secretary/Treasurer (copy attached) was disseminated to members prior to the meeting; motion made by Patrice Clark to accept the report, seconded by Dane Thibodeaux – the report of the Secretary/Treasurer was approved.

Old Business:

Regarding the scheduling of June and October meetings/exams, the meeting/exam date of Wednesday, June 16th was scheduled at the November 16th meeting and that meeting date was confirmed. The Board members agreed to table the scheduling of an October meeting/exam date until the June meeting.

Regarding continuing education approvals, the Board members agreed to re-approve the blanket approvals from 2020 and added a blanket approval for trainings sponsored by the New Orleans Mosquito, Termite and Rodent Control Board for trainings related to mosquito, termite, rodent and vector control only. Discussion on the continuing education course approval criteria; the approval criteria will be added to the website. Using the rubric evaluation tool, members reviewed pending continuing education requests.

New Business:

The Board members reviewed/approved the 2021 requests for Inactive Status, reviewed list of suspended licenses for delinquent renewals, and reviewed list of Provisional Licenses issued.

Discussion on adding an online application submission and payment process for temporary sanitarian permits and renewals. Justin Gremillion will review the application and website to see what could be done.
