#### 2024-25 FY GRANT REVIEW COMMITTEE REPORT:

Yolanda Motley presented the Grant Review Committee Report. Ms. Motley reported that 80 program applications were received totaling \$3,627,112.37. 9 Event/Conference applications were received totaling \$276,970.79.

A copy of the Grant Review Committee recommendations was distributed to Board Members. The Grant Review Committee is recommending funding for 65 out of the 80 applications received at a total of \$1,373,750. The Committee also recommends that 9 out of the 9 Event/Conference applications be funded at a total of \$144,985. The total of funding recommended is \$1,518,735. Discussion followed.
