He emphasized that this location is directly across the river from 18-20 residents of River View Acres, who believe that the Beaver Lake Renewables project would disrupt their quality of life. Mr. Fontenot insisted that alternative sites be thoroughly evaluated.

Mr. John Pickles was acknowledged, and he emphasized the importance of distinguishing between demanding and simply requesting customers to explore alternative sites
