The Executive Director announced the first order of business would be Hearing #2011-025, Vitacci Motorcycles, Inc. for **RULE TO SHOW CAUSE WHY CIVIL PENALTY SHALL NOT BE FULLY IMPOSED** regarding the alleged violations of LSA-R.S.32:1254A.(1) & (4) Application for license; requirements for licensure; contents; licenses; franchise filings; LSA-R.S.32:1261.(1)(h) Unauthorized acts; and Louisiana Administrative Code Title 46. Part V. Subpart 1. Chapter 5 §513A. License Prior to Shipment. A court reporter was brought in to record the transcript of this hearing, which will be made a permanent part of the Commission's files.

The Executive Director presented to the Commission Members a correspondence from E. Wade Shows, Attorney for Atterbery Truck Sales, Inc., dated November 7, 2011, requesting the Commission's support of Three-Member Board's Decision on Hearing #2010-053, Atterbery Truck Sales, Inc. vs. Navistar, Inc.:

"Pursuant to our recent conversation, please allow this letter to serve as my formal request to place an item on the agenda for the next regularly scheduled Louisiana Motor Vehicle Commission (hereinafter "Commission") Meeting. Specifically, I would like to address the Commission with respect to the following:

- 1) I would like to request that the Commission support the decision of their Three-Member Consumer Board that ruled in favor of Atterbery Truck Sales, Inc. on a motion for partial summary judgment in the matter of Atterbery Truck Sales, Inc. vs. Navistar, Inc., #2010-053, in the event that the ruling is appealed. The request is based upon the fact that the Three-Member Consumer Board is the Commission and the decisions that are made by the Three-Member Consumer Board should be supported.

- 2) I would also like to request that the Commission support the correct interpretation of Louisiana Revised Statute, Title 32, Section 1261 (1)(d), which reads:

'It shall be a violation of this Chapter for a manufacturer, a distributor, a wholesaler, distributor branch, factory branch, converter or officer, agent, or other representative thereof... to unfairly, without just cause and due regard to the equities of such dealer, cancel the franchise of any licensee...'

The above statute is intended and designed to prohibit manufacturer against and protect the dealers from cancellations that, although allowed by the franchise agreement, are otherwise unfair, without just case

and due regard to the equities of said dealer. The statute is not designed or intended to allow a manufacturer to cancel the franchise of a dealer without regard to the terms and conditions of the franchise agreement.

If the statute is allowed to be interpreted as giving manufacturers permission to cancel the franchise of a dealer, all dealers will be subject to cancellation, notwithstanding their franchise agreement.

Should you have any questions, please do not hesitate to contact me."

At this time, Chairman Brandt open the floor to Wade Shows, Esq. to addressed to the Commission members of regarding this issue. At the conclusion of Mr. Shows address the Commission entered into a brief discussion. The Chairman stated the three member consumer board was created by the legislature to hear manufacturer/dealer disputes. Counsel stated the two boards are to act independently of each other. Commissioner LeBlanc made a motion that Mr. Shows should request a meeting with the Three-Member Consumer Board in that this Commission lacks jurisdiction. Commissioner Timmons seconded this motion.

The Executive Director advised the Commission Members a bond waiver request had been received on November 8, 2011 from Seth Weinberg, General Counsel of The Vehicle Production Group LLC, along with a copy of VPG Marketing Plan power presentation:

"The Vehicle Production Group LLC ("VPG") appeared at the September 12, 2011 LMVC meeting and requested that Commission consider and grant a waiver of the §1254D(6)(a) \$1,000,000 bond requirement as it applies to VPG, until its next license renewal. As you know, the Commission expressed concerns at that meeting relating to VPG's financial position and , based on those concerns, denied VPG's request.

Since the time of the September 12th LMVC meeting, there have been positive developments related to VPG's financial position, including the completion of a new \$40,000,000 investment in VPG Holdings LLC and The Vehicle Production Group LLC by a new investor. This investment, in the form of subordinated convertible debt, was completed on October 31, 2011. We are in the process of preparing updated financial information for VPG reflecting this investment and will provide that information shortly.

The purpose of this letter is to provide you with this updated information regarding VPG and to inquire whether, in light of these developments, the LMVC would be willing to reconsider VPG's request for a waiver of the §1254D(6)(a) \$1,000,000 bond requirement as it applies to VPG. As discussed at the September 12th meeting, the reasons for this request include the following:

1. VPG does not plan to maintain an extensive dealership network in the State of Louisiana. VPG currently plans to maintain only one authorized VPG dealership in Louisiana, located in Baton Rouge;
2. VPG plans to sell a relatively small number of vehicles in Louisiana. VPG's 2012 vehicle sales forecast for Louisiana is approximately 36-48 vehicles and, VPG's 2013 sales forecast for Louisiana does not project a substantial increase from 2012 levels;
3. The associated cost to VPG on a per-vehicle-sold basis of providing a \$1,000,000 bond is disproportionate to the benefits gained from maintaining a dealer network in Louisiana.
4. VPG was established with the purpose of service to the disability community, a population historically underserved by OEM manufacturers;
5. VPG's method of operation in identifying dealer candidates has been to primarily seek out disenfranchised dealers of discontinued vehicles, such as Saturn and H2 vehicles, and offer them a way to repurpose their existing facilities without significant capital investment by becoming MV-1 franchise within an existing facility;
6. As a result of VPG's dealer model, which requires no new facilities and minimal capital investment on the part of VPG dealers, the aggregate capital commitment to VPG from a new dealer is less than \$10,000 (exclusive of inventory, which is to be drafted from a "floorplan" letter of credit on shipment of the vehicles). This \$10,000 total includes specialized tools, software licenses, signage, and fees to our third-party vendors for system set-up for reporting of warranty claims, and VPG is willing to have the amount escrowed with an escrow agent of the dealer's choosing;
7. VPG has invested very substantial sums in the development of its MV-1 program and, in addition, the US Department of Energy has provided an expense reimbursement loan of approximately \$50 million to VPG under the DOE's Advanced Technology Vehicles Manufacturing (ATVM) Loan Program;
8. In addition to the fact that AM General LLC is covering the first thirteen months of assembly warranties, VPG is in the final stated of securing insurance coverage to back its warranty from a major provider.

We are hopeful that this updated information will provide sufficient comfort to the LMVC to reconsider its initial position on VPG's request. Representatives of VPG are available to attend the LMVC meeting on November 14, 2011 to address any questions or concerns the Commission members may have regarding this new information. If, on the hand, the LMVC is not inclined to reconsider its initial position based on this new information, VPG will of course respect that position and wait until the next LMVC meeting, when it VPG will be further along in launching its business, to renew its request.

VPG continues to be committed to working with the LMVC to reach an outcome satisfactory to all parties and welcomes any suggestions the Commission may have with respect to a resolution of this issue that would ensure the successful distribution of the MV-1 vehicle in Louisiana.

The Executive Director advised the Commission Members that no one was present from The Vehicle Production Group. The Chairman deferred VPG's request to the next meeting.

The Executive Director presented to the Commission Members an e-mail correspondence received on November 7, 2011 from Beth Brockert, Vice-President of Jack Morton Worldwide on behalf of The Super Chevy Dealers of New Orleans:

Event: 2012 Allstate Sugar Bowl and 2012 BCS National Championship Football Games

Location: Mercedes Benz Superdome, New Orleans, LA

Dates: Sugar Bowl is January 3, 2012
BCS National Championship is January 9, 2012

Overview of sponsorship: The Super Chevy Dealers of New Orleans (LMA)* are the Official Vehicle of the 2012 Allstate Sugar Bowl and 2012 BCS National Championship games. As part of their involvement with the Sugar Bowl, the LMA has the opportunity to display seven (7) vehicles on-site at the Superdome. The LMA would like to get permission from the LMVC to place the seven (7) vehicles listed below at the Superdome on January 3, 2012 and January 9, 2012 for the entire day of the two different games. The vehicles will have door decals on them that say "Super Chevy Dealers, Official Vehicle of the Allstate Sugar Bowl" and "Super Chevy Dealers, Official Vehicles of the BCS National Championship". These vehicles will not be open and will remain locked the entire time. No dealership badging will be on the vehicles.

After a brief discussion, Commissioner Hargroder made a motion to approve The Super Chevy Dealers of New Orleans request to display seven new Chevrolet vehicles at the Mercedes Benz Superdome during the Allstate Sugar Bowl and BCS National Championship games on January 3, 2012 and January 9, 2012 conditioned upon the Law and the Rules and Regulations promulgated by this Commission being strictly adhered to and all representations made in the request correspondence of November 7, 2011, remaining constant. Commissioner Hocevar seconded this motion and it was unanimously approved.

The Executive Director reported to the Commission Members that Crestline Coach Ltd. submitted a request for a bond waiver for the required million dollar bond after the meeting agenda was posted. The correspondence was from Nicole Nickel, Executive Administrator of Crestline Coach Ltd, dated November 7, 2011:

"In regards to Crestline's application for a Converter/Secondary Manufacturer license please note that we are requesting to have the \$1,000,000.00 surety bond waived. Crestline Coach Ltd. is a reputable ambulance manufacturing company that has been around since 1975. Crestline head office and manufacturing facility is located in Saskatoon, Saskatchewan Canada and we have sales offices and dealers throughout Canada, the United States, and in Switzerland. We sell our product in numerous states and have licenses in such

locations as Oklahoma (Manufacturer license); Texas (Motor Vehicles Manufacturer license); Indiana (Distributor license); Washington (Motor Vehicle Dealer license and Vehicle Manufacturer license); Minnesota (Motor Vehicle Dealer license) and California (Vehicle Dealer License and Vehicle Manufacturer License).

We are applying for a Converter/Secondary Manufacturer license so our dealer, Hutchens Innovative Partners, LLC (dba Lonestar Emergency Vehicles) can represent our ambulances in the state of Louisiana. Please note that we have obtained a Certificate of Authority to transact business in this state (refer to Attachment 6 in the application).

The Executive Director advised the Commission Members that Crestline's request was sent to the Chairman for review and he recommended the approval of the bond waiver request. After a brief discussion, Commissioner Guidry made a motion to waive the bond requirement pursuant to LSA-R.S. 32:1254D(6)(a) for Crestline Coach Ltd. Commissioner Timmons seconded this motion and it was unanimously approved

With regard to the old business, Hyundai Assurance Trade-In Program, the Executive Director reported that she contacted Hyundai official. However, as of this morning no response from Hyundai. The Chairman defer this topic till a response is received from Hyundai.

The Executive Director advised the Commission Members that since 2009 when the Commission was given the licensing and regulating of the recreational product industry:

1. Total licenses issued have gone from approximately 11,500 to 21,000
2. The number of hearings have gone from 20 to 30 to around 130, thus hearing cost have risen.

The Executive Director continued by stating there had been unforeseen legal expenses relative to recreational products licensing, increased cases of litigations, and other legal issues. The Executive Director stated there was three months left in the current year of Counselor Reggie's two year contract and requested the following amendment to the contract be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed \$195,000.00 for the period commencing February 1, 2011 and ending on January 31, 2012." Additionally, the Executive Director stated there was less than three months left in the current year of Counselor LaPeyronnie's two year contract and requested the following amendment to the contract be approved: "The total of all sums payable under this contract including fees and reimbursement of expenses shall not exceed \$124,000.00 for the period commencing January 12, 2011 and ending on January 11, 2012." After a brief discussion, Commissioner Duhon made a motion to approve the amendment to Counselor Reggie's and Counselor LaPeyronnie's current contract. Commissioner Hargroder seconded this motion and it was unanimously approved.

With regard to the legal contracts, Commissioner Duhon made a motion to renew Counselor Reggie's contract for two year period, beginning February 1, 2012 and ending on January 31, 2014, for the total of all sums payable under the contract including fees and reimbursement of expenses not exceeding \$180,000.00 on an annual basis; and to renew Counselor LaPeyronnie's contract for a two year period, beginning January 12, 2012 and ending on January 11, 2014, for the total of all sums payable under the contract including fees and reimbursement of expenses not exceeding \$120,000.00 on an annual basis. Commissioner Westbrook seconded this motion and it was unanimously approved




