After much discussion a motion was made by Mr. Magnon that Mr. McCay collaborate with Mr. Williams to draft a policy similar to the Civil Service Board. Once drafted, the Committee will call a special meeting to consider the draft. The motion was seconded by Ms. Mize and it was approved.

The Committee suggested that Mr.'s. Dunham and Aucoin be issued Provisional certificates pending a change in the Program's minimum educational policy.
