APPLICATIONS REVIEWED

<u>Case No. 18-02-10</u>: Participant is requesting a full distribution of her account balance of \$9,090 to prevent eviction.

The Hardship Committee approved a partial distribution in the amount of \$8,250 based on documentation submitted.

<u>Case No. 18-02-11</u>: Participant is requesting a partial distribution in the amount of \$3,834.90 of her account balance of \$9,151.65 for medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$3,834.90 based on documentation submitted.

<u>Case No. 18-02-12</u>: Participant is requesting a partial distribution in the amount of \$5,000 of her account balance of \$16,480.12 for mortgage payments that are delinquent.

<u>Case No. 18-02-16</u>: Participant is requesting a full distribution of her account balance of \$4,872.25 for medical expenses.

The Hardship Committee approved a partial distribution in the amount of \$994.70 based on documentation submitted.

<u>Case No. 18-01-07</u>: <u>APPEAL</u>: Participant has submitted an appeal regarding her hardship application in January. Participant has submitted additional documentation that was requested. Participant is requesting a partial distribution in the amount of \$1,000 of her account balance of \$1,255.12 for home repairs.

The Hardship Committee approved a partial distribution in the amount of \$1,000 based on documentation submitted.

<u>Case No. 18-02-17</u>: Participant is requesting a partial distribution in the amount of \$10,000 of his account balance of \$122,243.32 for damages his mother received from Hurricane Harvey flooding on August 23, 2017.

The Hardship Committee approved a partial distribution in the amount of \$10,000 based on the provisions of the TX-2017-09, Tax Relief for Victims of Hurricane Harvey in Texas, Announcement 2017-11, Relief for Victims of Hurricane Harvey. Participant met the guidelines of his mother living in an affected county.

<u>Case No. 18-02-18</u>: Participant is requesting a partial distribution in the amount of \$30,000 of her account balance of \$34,277.04 for damages she received from Hurricane Harvey flooding on August 23, 2017.

The Hardship Committee approved a partial distribution in the amount of \$30,000 based on the provisions of the TX-2017-09, Tax Relief for Victims of Hurricane Harvey in Texas, Announcement 2017-11, Relief for Victims of Hurricane Harvey. Participant met the guidelines of living in an affected parish.
