<u>Case No. 18-05-37:</u> Participant is requesting a partial distribution in the amount of \$9,790.55 of her account balance of \$42,080.26 for funeral expenses

The Hardship Committee approved a partial distribution in the amount of \$9,790.55 based on documentation submitted for funeral expenses.

<u>Case No. 18-05-38:</u> Participant is requesting a full distribution of his account balance of \$2,252.91 for loss of wages

The Hardship Committee approved a full distribution in the amount of \$2,252.91 based on documentation submitted for loss of wages.

<u>Case No. 18-05-39:</u> Participant is requesting a full distribution of his account balance of \$7,593.08 for funeral expenses.

<u>Case No. 18-05-43:</u> Participant is requesting a full distribution of her account balance of \$10,254.74 for loss of wages.
