<u>Case No. 19-06-43:</u> Participant is requesting a full withdrawal of her account balance of \$3,660.39 for mortgage payments that are in foreclosure.

Case No. 19-06-44: Participant is requesting a full withdrawal of her account balance of \$5,660 for mortgage payments that delinquent.
