<u>Case No. 2015-10-52</u>: Participant is requesting a partial distribution in the amount of \$3,500 of her account balance of \$7,944.54 for mortgage payments that are in foreclosure.

The Hardship Committee approved a partial distribution in the amount of \$3,337.40 based on documentation submitted.
