Council members Vance Gordon, Nelson “Snoop” Roth, Mike Rainwater, Alexander Perret, Darryl Carpenter, Jeff DeBlieux, David Rousseau, Eric Sunstrom, and Donald Reed were absent from the meeting. The Bayou State Bow Hunters Association has disbanded, and Shane Crochet will no longer be a member. **A quorum was not present; therefore, this was not an official meeting.** The following constitutes a brief report of what was heard.

The **minutes of the March 15, 2012** meeting were not voted on, as there was not a quorum.

Lt. Col. Jeff Mayne provided the Enforcement Division report. Chairman Crews noted that DWI’s seem to be up, and Col. Mayne stated that more officers are trained so detection is up. There was a brief discussion on DWI’s.

Lt. Col. Mayne also provide an update on the 2012 Regular Session of the Louisiana Legislature, touching on items that were significant to the department.

Mr. Larry Reynolds addressed the Council, providing information on the new zones and splits for waterfowl season. He addressed the new third (Coastal) zone that was added, and the council discussed the issue.

There was a brief discussion on the HFAEC page on the department’s website, specifically addressing powers, duties and responsibilities. Chairman Crews requested this item be on the agenda for the next meeting.

The Council set the **Next Meeting Date** for Tuesday, October 9, 2012 beginning at 1:30 PM. Requests were made to hear information on Rigs to Reef, as well as a trapping update.
