

AAHSD Board Meeting Minutes August 21, 2023

Meeting held at 302 Dulles Dr. Lafayette, LA. 70506. Auditorium #4.

- Comments from the Executive Director:
 - CCBHC update: Updates given by the ED. Discussed the meeting with the GPO (Grant Project Officer). In the process of hiring staff for CCBHC. Developing DCO (Designated Collaborative Organization) agreements. Will turn in a self-attestation by end of September. Progress is going well and AAHSD is meeting the criteria for the project.
 - Same Day Access update: Explained the SDA program funded by SAMHSA. AAHSD was awarded a grant for this program. The Gap Analysis is completed. Discussed meetings of the Rapid Cycle Change Team. Planning to implement the program April 2024. Expanded days and hours are being discussed and are consulting with MTM Services.

- Legislative presentation: ED notes he, along with LDH/OBH, will be attending and making a presentation at the Subcommittee on Mental Health of House Committee on Health & Welfare meeting in Baton Rouge on 8/24/2023.
- OBH statewide crisis meetings: A schedule of the LDH Crisis Regional Tour 2023 is provided to the Board. Meeting scheduled for Lafayette 8/22/2023.
- Open Meetings Law revision SB 201/Act 393: A discussion is held on the changes in the Open Meetings Law and ED will keep the Board updated.
- o HSIC Annual Meeting: ED informed the Board that the ten (10) LGE Board Chairs and/or their designees shall be in attendance at the LDH meeting in October or November 2023 to facilitate fostering and exchange of the best practices to ensure each district is maximizing its services. Each Board Chair and/or their designee shall give a presentation of the status of services in their district, asks how the Board will benefit from this meeting, and what information would the Board like presented. Suggestions from the Board members were Board development, advocate for their community, most & least successful practices and policy review. These suggestions will be relayed to LDH.
