The business meeting was called to order following Chairman, Richard Fontenot's, welcome to the group and explanation of Governor Edwards' order to allow virtual attendance of Board and Commission meetings due to the COVID-19 pandemic. Fontenot asked the group to mindful of social distancing protocols and thanked LSU personnel for making sure the meeting could be conducted as such.

ACTION

#1

A motion was made by Jude Doise, seconded by Jeffrey Sylvester and carried, to approve the implementation of Govenor Edwards' order and suspend committee protocols to allow for virtual attendance.

Chairman Fontenot then began self-introductions, first by turning the floor to Commissioner Strain's new board designee from LDAF, Lester Cannon. Cannon noted he'd replace Benjy Rayburn following Rayburn's retirement. Lester listed his responsibilities with LDAF, including a recent addition of overseeing the Hemp program. Fontenot welcomed Cannon following all board members introducing themselves and noted Rayburn's years of quality service to the board and LDAF.

The Board next considered the proposed agenda for the meeting.

Action 2 A motion was made by Gerald Leonards, seconded by Sylvester and carried to approve the agenda as presented

The Board next considered the minutes of the previous meeting.

ACTION #3

A motion was made by Jeffrey Sylvester, seconded by Leonards and carried, to approve the minutes of the previous meeting on July 1, 2020.

Andy Brown then presented a collections report for both fiscal year end (FY2020) and for YTD Sept 2020. Brown noted the collections were up \$39,428 over budget projections FY2020 creating a carryover surplus. For the month of September assessment collections were \$95,414. The year to date assessment collections were \$138,661 and year to date refunds were \$2550. Brown had spoken with LDAF, and October collections report was being completed, but would not be available for this meeting. Brown then began to walk the board through other financial projections that would be considered later in the meeting for budgeting purposes.

Scott Soileau then reviewed the previous year end June 30, 2020 financial operating report (FY2020). He reviewed each of the various fund balances and discussed the current financial position of the Board. The Board discussed their current financial position and the current fund balances. Of note, Soileau mentioned a higher COL-Rice collection for the year than anticipated. He expected pace to return closer to trend in coming months. Soileau also noted the contributions to the LSU Foundation Endowment had reached the initial goal of \$2.5 million from contributions made in FY20.

Action #4 A motion was made by Kim Frey, Seconded by Leonards and carried, to receive and file the collections and financial reports presented.

For interest of time, Chairman Fontenot then asked the board to consider allowing USA Rice Report earlier in the agenda. With no objections, various USA Rice staff shared information about the virtual format for the 2020 Rice Outlook Conference. Steve Lindscomb gave updates regarding foundation programs, postponement of Rice Leadership activities, and updates regarding foundation research. Michael Klein and Sarah Moran gave project updates, with Moran's report relating to TRQ fund projections discussed in the financial report.

The Intellectual Property Committee report was then presented by committee chairman John Dennison. This year \$150,000 was available for projects. The committee recommend funding project requests as presented (attached). Chairman Fontenot reviewed the committee's purpose and the funding process, with he and Dennison noting that these funds would continue to decrease over time unless new IP contract were agreed to. Mike Salassi reminded the Board that the LSU AgCenter royalty funds are not transferred to the Board but are allocated to projects recommended by the committee and approved by the Board under the MOU. The majority of royalties come from technology used in other states and countries. Royalties will decline as patents roll

off. The committee also heard from Salassi on a potential agreement between the LSU AgCenter and a private company Nutrian Ag Solutions to partner in breeding efforts. Salassi noted this would get more up front contribution from a company who would likely benefit from breeding efforts at LSU.

ACTION #4 A motion was made by Jeffrey Sylvester, seconded by Dane Hebert and carried to approve the funding recommendations of the IP Committee of totaling \$150,000 with \$20,000 for rice/crawfish project request, \$39,500 for a research specialist, and \$90,500 to support farm management.

The Board then considered Col-Rice Fund Use Committee report and funding recommendations for Col-Rice TRQ funds. Dane Hebert presented the Col-Rice Committee report and recommendations. The Committee discussed the endowment and the success to reach \$2.5 million. The Committee recommended the funding of one project, \$20,000 for black bird control for 2021. They also recommended allocating the remainder of Col-Rice TRQ funds of \$660,000 to be made available for two plot combines (one for pest management and one for weed control projects) and a flex harrow for the South Farm. The Board discussed how the Col-Rice TRQ funds became available, the process in place and the future of this source of revenue.

ACTION #6 A motion was made from the committee's action through Dane Hebert, seconded by Gerald Leonards and carried, that the Col-Rice committee recommendations for Col Rice TRQ funds be approved as presented for \$20,000 be allocated for 2021 black bird depredation and the allocation of an additional \$660,000 for equipment needs requested (two plot combines (one for pest management and one for weed control projects) and a flex harrow for the South Farm).

The Board then considered representation for Louisiana on the national Col-Rice Committee. Chairman Fontenot noted that John Dennison had been serving in this role and was interested in continuing to serve. Discussion ensued amongst the board on the role of this committee.

ACTION #7 A motion was made by Gerald Leonards, seconded by John Earls and carried to reappoint John Dennison as Louisiana's Col-Rice representative.

The Board then considered the checkoff assessment and EU TRQ income estimates and operating budget. Andy Brown reviewed the assessment income for this year's crop, checkoff income balances as of 6/30/20 and the board's operational budget estimates for FY 2021. After some discussion and general agreement on income estimates and operating expenses, the Board began to discuss the proposed research projects (continuing and new) and the funding requests. Other budget considerations, such as legal fees and projections on future TRQ incomes were discussed. Chairman

Fontenot charged the group to give extra consideration to the validity and usefulness of projects funded, to not become dependent on TRQ funds for research. FY2020's short crop required use of TRQ funds for research, Fontenot noted, but that becoming dependent on those dollars would be a disservice to the researchers moving forward if that funding continues to decrease as projected.

The Board then entered into review of each continuing project and established funding levels for 2021 by reducing some projects and maintaining some others at their 2020 levels. The Board then reviewed new projects and selected new projects to be funded for 2021.

ACTION #9 A motion was made by Dane Hebert, seconded by John Dennison and carried to approve funding levels for the LSU AgCenter 2021 new and continuing projects at a total funding level \$2,100,220. (Continued projects should be funded at \$1,701,909, \$62,200 for new, \$330,041 from remaining COL-Rice funds and \$6070 from EU-TRQ funds)

Dr. Salassi then discussed faculty changes, announcing Dustin Harrell as the new Rice Station Director upon Don Groth's retirement. Harrell would thus turn over his extension specialist duties upon this new appointment. The Board congratulated Dustin on his appointment and thanked Dr. Groth for his great years of work.

Dr. Salassi introduced Andrew Schade, a representative for the LSU Foundation, who then gave the 2020 Endowment Report, updating the board on the performance of the invested funds and allocation of funds (report attached).

The approved projects, final funding level allocations and budget are attached. After agreeing to the 2020 funding allocations and budget, the Board considered the necessary contracts for 2020.

ACTION #10 A motion was made by John Dennison, seconded by Damian Bollich and carried to approve the funding levels, budget and necessary contracts for FY2021 with organizations and individuals in the amounts agreed to in the approved operating budget and project allocations; USA Rice up to \$15,060; The Rice Foundation \$35,000; accounting with Dugas, Soileau and Breaux \$1,600; administrative with Andy Brown \$2,000. LSU AgCenter in the amount of \$2,237,706 for projects and \$500,000 for an endowment installment at the LSU Foundation.

Andy Brown then briefly reviewed the ethics training and reporting requirements for Board members. The online ethics training is an annual requirement to be fulfilled by the end of the year. Members were encouraged to send their completion certificate to Andy Brown via email. There is also a new requirement for a virtual sexual harassment

training that Brown had distributed electronically.

Fontenot concluded business by giving a brief legal matters update. There had been some activity regarding appeals, with some reaching the state supreme court in coming months.

The next Board meeting would potentially be held in June 2021 immediately following the field day program, depending on COVID restrictions at that time.

The Public Comment period was held. No comments were received.

There being no further business the meeting was adjourned.

Chairman, Richard Fontenot called the Louisiana Rice Research Board (LRRB) meeting to order at 1:05 pm and asked members to review the agenda items. He spoke to the procedural changes due to COVID-19 requiring social distancing and Govenor Edwards Executive Order to allow for electronic attendance. Fontenot welcomed those attending electronically and checked the audio/visual. He also recognized the faculty and staff of LSU who had accommodated these changes.

ACTION A motion was made by Kim Frey, seconded by Jeffery Sylvester and carried, to approve the agenda.

Chairman Fontenot then asked board members to review the minutes while he gave a brief chairman's report. He reminded the board the minutes were sent electronically, but encouraged them to again review them presented at the meeting. The chairman's report mentioned the LSU online field day and encouraged members and guests to review the presentations that had been made earlier in the day via the online field day website. He briefly charged the board with their intent to consider the research presented through this field day and other updates they would hear in this meeting, outlined the subcommittees and their particular responsibilities to keep them mindful of the members' respective assignments, and again thanked LSU for accommodating the challenging times to still provide growers with quality information. He concluded by asking director Andy Brown to call the roll of the board.

The Board next considered the minutes of the previous meeting which had been sent to all members.

ACTION A motion was made by Sammy Noel, seconded by Gerry Leonards and carried, to dispense with the reading of the minutes and approve them as presented.

The LDAF May 2020 assessment collections report was then presented by Andy Brown. For the month of May assessment collections paid to the Board (gross) was \$42,354.30. The year to date gross assessment collections were \$1,314,775.09 and year to date refunds were \$113,561.09. The year to date collections were on track with budget estimates with a net of \$1,189,214.00 with June collections left to go.

Scott Soileau then reviewed the May 31, 2020 financial operating report. He reviewed each of the various fund balances and discussed the current financial position of the Board. The Board discussed their current financial position and the current fund balances in regards to refunds and disbursements.

Col-Rice Representative John Denison then gave a report on the Col-Rice Board activities. The Board had not met in person due to COVID-19. Mr. Denison reported funds were up due to a January tender, exceeding budget projections. Figures had already been covered in Mr. Soileau's report. Denison spoke to the challenges for the group to do trade missions or outreach due to pandemic, but were still seeing positive results due to demand for rice during the times of COVID-19.

ACTION A motion was made by John Denison, seconded by Sammy Noel and carried, to receive and file the financial and collections reports.

Chairman Fontenot reported that John Denison had served in 2019-2020 as the Col-Rice Board and thanked him for his service. He then reviewed the structure of Dennison chairing the IP subcommittee for LRRB and Dane Hebert chairing the subcommittee for COL-Rice for LRRB. But explained Dennison's role as a national COL-Rice representative gave the board some checks and balances over those funds both internally and externally.

ACTION A motion was made by Jude Doise, seconded by Eric Savant and approved that John Denison continue serving as Louisiana's director on the Col-Rice Board.

Fontenot the review subcommittee assignments. LRRB Col-Rice Committee was then discussed, as members currently serving were asked their pleasure on continuing to serve on this subcommittee. Dane Hebert (chair), David LaCour, Jeffery Sylvester, and Gerald Leonards were reappointed to this subcommittee by unanimous consent. Similarly, the IP committee members John Dennison (chair), Alan Lawson, Jude Doise, Jason Waller, and Sammy Noel were reappointed to this subcommittee by unanimous consent.

Fontenot then described the idea for a new subcommittee, Program Development. This committee would be charged with reviewing research priorities,

polling farmer and checkoff contributors as to their interests, and would work with LSU and other PI's to focus the scope of research to best match these priorities and farmer interests. The board discussed this committee favorably, going over a timeline and logistics of the subcommittee forming and meeting before the November proposal meeting. LSU personnel also joined the discussion to best meet the needs of the researchers and administration to accomplish these new goals.

ACTION A motion was made by Eric Savant, seconded by Damian Bollich and carried, that the Board approve the formation of the new Program Development Committee.

Fontenot then discussed with members who did not already have a committee assignment their willingness to join the new PD committee. Eric Savant, who had omitted himself from the COL-Rice committee nominations agreed to serve now on PD and was joined by Damian Bollich and Kim Frey who had not previously served on a subcommittee to form the new PD committee. John Earles would replace Eric Savant on COL-Rice. And Fontenot would chair the PD committee.

Dr. Mike Salassi then updated the board on the LSU virtual field day. He mentioned that LSU would likely try to blend the inperson and virtual formats moving forward, making the research presentations more accessible year round.

Salassi then began a presentation on an agreement LSU was proposed to enter into with Nutrien Ag. Adam Famoso joined the presentation as well discussing the agreement terms, access to a new breeding facility, and current challenges on the breeding program with facility, budget and personnel restraints. LSU Staff reassured the board this agreement would not influence the release of conventional varities, with only one variety being offered to Nutrien Ag for patent and sale. Doise and Noel suggested LA farmers should receive some sort of discount/rebate for the one variety dealt to this company and LSU agreed to pass along that suggestion to Nutrien Ag. LSU also mentioned LRRB would be consulted on the conventional variety dealt to Nutrien Ag at a later date. LSU concluded the presentation with benefits of the deal and how it would enhance the overall breeding program, allowing for more return on investment LRRB dollars.

Betsy Ward, CEO USA Rice, then addressed the board electronically, inviting board members to attend the electronic USA Rice Board meeting the second week of July. Betsy discussed challenges USA Rice was facing for meetings due to COVID. She discussed options for the Outlook conference, USA Rice financials, and other research related efforts.

Kane Webb then presented information about the LA Rice Growers new website, directory updates, and a report from the LA Rice Growers Assoc. Meeting. The new LRGA website was released that morning along with the LSU Field Day.

Dr. Linscombe gave an update regarding the USA Rice Foundation and thanked the board for their support. Dr. Linscombe discussed Latin America Rice Quality Research, highlighting the work of Adam Famoso, targeting taste preferences and the impact that could have for the LA rice market. Lindscombe then made a request for

states to reimburse USA Rice Foundation for the cost of this project, prorated by acres grown in each state. John Dennison shared experiences of visiting Latin America and supported the work.

ACTION #8

A motion was made by John Dennison, seconded by Eric Savant, and carried for LRRB to contribute \$22,100 to this Latin America Preferences Project, to be budgeted at the November 2020 meeting.

Fontenot briefly discussed the lack of movement on legal challenges involving LRRB and mentioned motions that had been filed in appellate court for the defendants. No ruling had been made at the time of the meeting regarding these motions.

Chairman Fontenot then asked Brown to briefly review the ethics training and reporting requirements for Board members. Members will receive reminder emails and texts from Andy Brown, of which he had done for previous deadline in May 2020.

Fontenot then displayed the Governor's proclamation allowing for electronic attendance and asked for any public comment. No guests raised any questions.

ACTION

#9

A motion was made by John Dennison, seconded by Gerald Leonards and carried to suspend LRRB rules to adhere to Governor Edwards' Proclamation regarding electronic attendance due to COVID-19 for this meeting.

Chairman Fontenot brought up the election of officers.

ACTION #10 A motion was made by Jeffrey Sylvester, seconded by Damian Bollich, and carried to reelect all officers for the 2020-2021 term whereas Richard Fontenot – Chairman, Dane Hebert – Vice Chairman, and John Dennison – Secretary/Treasurer.

The next meeting date was tentatively set for Thursday, November 5th. This would be the project review meeting. Committee meetings were also tentatively scheduled prior to the full meeting. Both IP and Col-Rice will meet October 29th, with IP meetings at 10:00 am and Col-Rice at 1:00pm. A meal will be provided between meetings for both committees. PD Committee would meet at the request of the Chairman once the committee was better established.

There being no further business the meeting was adjourned from a motion from Jeffrey Sylvester, seconded and carried by Kim Frey.

Committee Chairman John Denison called the meeting to order with self-introductions and reviewed the purpose of the meeting. The agenda was reviewed.

Action #1: A motion was made by Sammy Noel, seconded by Jude Doise and carried, to approve the agenda as presented.

The minutes of the previous meeting were then considered. While the minutes were being read Andy Brown pointed out the 2020 funding information for reference later in the meeting. Don Groth then updated the group about 2020 funding. He highlighted the crawfish project, mentioning oxygen sensor work and other extension materials resulting from the project. Groth also mentioned renovations of Greenhouse #3 were complete and staff had begun the move in process.

Action #2: A motion was made by Jude Doise, seconded by Alan Lawson and carried, to approve the minutes as presented.

Mike Salassi gave background on the process and future projections of the intellectual property of the LSU AgCenter. Salassi gave a brief recap of the MOU between LRRB and the LSU AgCenter and other historical context about the purpose of the committee. Dr. Salassi and Dr. Guiry noted that the predicted reduction in Clearfield technology royalties. The MOU allows for 1% of collections, or 10% of LSU's share of overall revenue be stewarded by the IP Committee. Dr. Guidry and Dr. Harrell referenced continued development of Provisia technologies were moving forward. For 2020, the IP committee's allotment for project recommendation amounts to \$150,000; \$75,000 in royalties matched by AgCenter funds.

Groth and Dennison then reviewed the proposed requests for 2021. It was noted that the farm manager request was only a portion of funds needed for that position, but Groth fit the request to budget constraints.

Sammy Noel then discussed crawfish research and updated the group on impacts from the Apple Snail. He mentioned the invasive pest was spreading and was a threat to rice and crawfish production moving forward. Harrell shared what treatment options were available and what work was being done with LSU to address the pest, but agreed further study needed to be done to find more control options and to take in consideration spread on public waters or other lands not in rice/crawfish production.

Action #3: A motion was made by Jude Doise, seconded by Alan Lawson and carried, to accept the projects as presented (requests attached) totaling \$150,000 for 2021.

Dr. Salassi then began a discussion with the committee on the finalizing of an agreement between Nutrien Ag and the LSU AgCenter. He also said negotiations were occurring on restructuring IP agreements and other opportunities with BASF. With IP royalties declining, LSU was looking for these companies to put up monies on the front end of research agreements to help sustain variety and other technology work that would bring revenue to both partners, hopefully, in future release of hybrids and other rice technologies. The group discussed Provisia and its continued development with Dr. Harrell. Salassi reminded the committee of the details of the Nutrien agreement, with discussion occurring about their acquiring of one convential variety developed by LSU, in exchange for funding and future partnership in facilities, personnel, and royalty income.

Andy Brown then addressed the committee about overall Board projections on checkoff and other revenues, preparing them for the full board meeting on the 5th of November. Following Brown's remarks, Richard Fontenot expressed appreciation to the LSU AgCenter and its leadership for the continued opportunity to make recommendations on a percentage of these funds. He also made comments about agenda items for the full board meeting, as well as thanked the committee for working to steward IP dollars to return value back to the LA rice industry.

There being no additional business the meeting was adjourned.

LOUISIANA RICE RESEARCH BOARD COL-RICE COMMITTEE MEETING

Draft Minutes

COL-RICE Committee Chairman Dane Hebert called the committee meeting to order. Self-introductions of committee members and guests were conducted. The committee agenda was read charging the committee to begin the process of prioritizing the use of COL-RICE research funds and develop recommendations for the LRRB to consider. The draft agenda was reviewed and discussed.

ACTION #1 A motion was made by, Gerald Leonards seconded by David LaCour and carried, to approve the meeting agenda.

The minutes of the previous meeting were dispersed as handouts.

ACTION #2 A motion was made by Gerald Leonards, seconded by David LaCour and carried,

to approve the previous committee meeting minutes as presented.

Andy Brown presented the history of TRQ funds and updated the committee on current funding status. Brown distributed financials of the 2020 TRQ collections (attached). The history of the funds has established a precedent of only appropriating funds collected, rather than projecting funds into the future. The report presented includes October sales projections, only because Brown believes the Board will have the actual results by the budget meeting for the full Board in the following week. Brown continued by distributing a breakdown of TRQ collections and a balance sheet showing a balance of \$1,602,673.02 for appropriation by the committee. It was explained this excludes \$1.5 million held in reserve, as established in LRRB policies in 2014, but does include October projections and projected interest income of \$8,000.

Brown then transitioned into a briefing on the overall collections and disbursements of the LRRB for 2020, pointing to remaining payments for 2020 contracts. Brown reviewed 2019 projections estimated a decrease in COL-RICE funds for 2020, but that actual sales were substantially higher, leaving the committee with a more favorable funding position for 2021 requests.

Chairman Hebert requested to move forward in the agenda to hear all proposed funding, first with an update on the endowed chair previous COL-Rice dollars have supported.

Richard Fontenot addressed the group virtually, noting a balance of \$2.5 million in the endowment. Fontenot referenced goals of the board to get the endowment above \$3 million for a higher rate of return to provide itself more useful for the chair with increased expendable funds. Hebert then asked current chair Don Groth to update the committee on returns and how they are being used. Groth stated current endowment funds have purchased bulk seed, fertilizer, chemicals, and other inputs across the rice station to support the entire portfolio of research projects and station activities. Mike Salassi shared that this rate of return is dependent on interest rates and other investment factors. He reminded the committee of fees assessed on the endowment and also referenced the board's previous goals and ability to see a higher rate of return with further investment.

Discussion ensued between committee members and guests on priorities and the financial priorities for the 2021 proposed funding. Dr. Groth led the group through the requests (attached).

The group then began a lengthy discussion on historical priority of use of TRQ funds for infrastructure, as opposed to short term funding of research projects. It was discussed about the increase in dependency on TRQ dollars for research projects and how that would present challenges as TRQ funds decreased, as research projects typically only increase in cost over the life of the project. Committee members asked questions about the need for two combines, as requested, and the differences between brands/models. LSU personnel discussed timely harvest challenges, the effectiveness of the black bird project, and the efficiency provided by the flex harrow requested that was in use on the "North farm" with a need for another on the "South Farm".

Brown reminded the group of the approval for funding of a USA Rice Foundation project from the July 2020 board meeting. He explained this did not have to come from TRQ funds, but that it would have to be considered in the overall budget process at the full November board/budget meeting.

Hebert, Leonards, and Fontenot all spoke of the importance of the endowment and shared their desire to see the \$3 million goal reached for return on TRQ dollars in perpetuity. Earles pointed out the need for harvest efficiency for accurate research data and supported the combine proposals as necessary for success of the checkoff dollars spent annually on research. He also supported the idea of infrastructure improvements for long term success of numerous research projects. Different funding scenarios were run at the request of Andy Brown and he shared the overall Board budget effects from those changes.

ACTION #3 A motion was made by Gerald Leonards, seconded by David LaCour and carried, to recommend to the LRRB that Col-Rice funds be utilized in prioritized order of further contribution to the chair endowment at \$500,000; fulfilling the requested \$680,000 requests from LSU as presented (\$20,000 for black bird project; \$360,000 for Wintersteiger combine; \$280,000 for a Zurn Combine; \$20,000 for south farm flex harrow); \$30,000 towards 2021 Rice Foundation Dues; \$22,100 for USA Rice Foundation project with Dr. Linscombe; and the remaining balance of approximately \$370,573 to be considered for use on research projects.

Gerald Leonards then confirmed with Fontenot that this would be strictly a recommendation to the Board from the committee. Fontenot and Hebert discussed with committee members the need to look at the research proposals ahead of the November meeting and requested Brown provide historical context of COL-Rice funding in relation to research project based funding and infrastructure and other asset purchases and improvements.

There being no additional business the meeting was adjourned.

SUBJECT: Sexual Harassment - Notice of Personal Liability

In the 2019 Regular Legislative Session, the legislature enacted La. R.S. 42:351-354, which reiterates the illegality of sexual harassment under state and federal law, and the requirement that government agencies develop and implement policies and related training to prevent such behavior in the workplace. Importantly, this legislation also created new law which imposes potential personal financial liability upon public servants determined to have engaged in sexually inappropriate workplace behavior.

I am required to provide annual notice to agency heads of this potential personal liability. You are required to ensure that this notice is disseminated to every newly employed, appointed and elected public servant. You must also disseminate this notice to every public servant in your agency on an annual basis.

I urge you to supplement your agency's existing policy prohibiting sexual harassment to include reference to this potential personal liability. For new hires, this notice should be provided during orientation, along with a copy of your agency's policy. For existing employees, this notice should be included in your agency's annual training on sexual harassment.

SEXUAL HARASSMENT

NOTICE OF PERSONAL LIABILITY

Louisiana law requires government agencies to develop and implement policies and related training to prevent sexual harassment in the workplace. The prohibitions and requirements within these policies apply to all public servants -- employees, appointees and elected officials.

Taxpayers are financially burdened by judgments and settlements arising from claims of sexual harassment. To reduce this impact, La. R.S. 42:351 declares that consideration be given to requiring that a public servant, determined to have engaged in sexually inappropriate behavior, personally reimburse all or a portion of any such judgment or settlement. La. R.S. 42:353 sets forth the process and factors to be considered in making this determination, and authorizes the Attorney General to file suit against a public servant to enforce the state's right to reimbursement and indemnification.

Notice of this potential personal liability is to be disseminated, along with the agency's policy prohibiting sexual harassment, to every newly hired public servant. This notice also is to be disseminated, on an annual basis, to every public servant in the executive branch of state government.
