· **LADOTD Dam Inspection / Level Gauge– J. Atherton**

o Dam Inspection Report 7/13/23 – New inspection report available to Commissioners contained same items from previous reports.

DOTD to re-connect center buoys.

o Gauge for dam – if purchased by Saline Commission:

· Gauge - \$7,000 (120V power)

· Installation - < \$1,000

· Air time - \$250 /year

· Need SWEPCO 120V power to dam

Ø Might need meter at transformer pole

Ø Will need undewirground power run to dam – 420 ft

Ø Will need conduit power run on dam – 100 ft
