1. GCIF and SIF Balances

Mrs. Fitzgerald stated that the balance of the Grain and Cotton Indemnity Fund is \$4,949,184 and the Self-Insurance Fund is \$930,224. Mrs. Fitzgerald reminded the board that the cap for collection of the Grain and Cotton Indemnity Fund is \$6 million dollars at which time collection would stop. Collection of the Grain and Cotton Indemnity Fund wouldn't restart again until the balance reached below \$3 million.

VII. New Business

2018 Legislative Session Update - Mrs. Fitzgerald stated that House Bill 313 by Representative Andy Anders has now become Act 8. House Bill 313 changes the number of meetings per year from four to three. Mrs. Fitzgerald also stated that Senate Bill 1 by Senator Allain from the 2018 Second Extraordinary Session provides for the transfer, deposit and use of monies among state funds. Assistant Commissioner for the office of Agro Consumer Services, Steve Sessums spoke about the current laws stating that once the projected budget is one percent less than the one last year they can tap into any dedicated funds to the amount of five percent and this amount shall be available. The new bill states that the amount shall be transferred and deposited in the State General Fund. discussion among the board members stating strong opposition regarding the sweeping of statutorily dedicated funds from both the Grain and Cotton Indemnity Fund and the Self-Insurance Fund, it was decided and voted upon that a letter be sent to all legislators, written and sent by the board members, opposing the sweeping of any funds from statutorily dedicated funds. A motion was made by Mr. Donald Berken and seconded by Mr. Tom Russell. Motion carried unanimously.

Mr. Hanks asked if there was any public comment. There was none.
