#### 1. Chair of the Board Report

Chair Hardy provided the following report:

- ❖ Shared that Supervisor Jackson & Chair Hardy, along with Chancellor Natalie Harder and René Cintron attended the ACCT GISS event earlier in the week.
- ❖ Informed the Board that Supervisor Stevie Smith returned from an educational trip to Amsterdam with students from Fletcher, Delgado, Northshore and River Parishes community colleges. During a future meeting, Supervisor Smith and one or more of the students will share their experience with the Board.
- ❖ Encouraged members to attend the SkillsUSA Postsecondary State Competition that will take place at SOWELA Technical Community College on April 19th and 20th.
- ❖ Reminded members that the Phi Theta Kappa Honors Luncheon will take place on April 27th in Baton Rouge. An invitation was sent to each of you previously. RSVP to Sara if you plan on attending.
- ❖ Congratulated Northshore Technical Community College on the recent groundbreaking for the STEM Campus Phase II project.

- ❖ Commencement season is rapidly approaching. A schedule of LCTCS commencements has been provided to you at your stations and sent via email. I urge my fellow Board members to attend at least one commencement this spring. Please let Sara Kleinpeter know your plans on attending. She can help with regalia.
- ❖ As is protocol for open meetings, there is an opportunity for public comment at the end of the meeting. If you wish to make comments to the board, please fill out a comment card and turn it in to Sara Kleinpeter, Board Coordinator.

## 2. President's Report

Dr. Sullivan provided the following report:

- ❖ Congratulated Ms. Christine Peyton from SLCC, for being named the 2018 Communicator of the Year for the National Council for Marketing & Public Relations and recognized SLCC Chancellor Dr. Natalie Harder for receiving the 2018 Joe Savoie Executive Leadership Award from CASE District 4.

Chancellor Harder introduced Ms. Payton to the Board, noting the pleasure it is to work with her. Ms. Payton thanked the Board for their time and expressed her gratitude to them and her colleagues from LCTCS for allowing her to do a job that she loves.

- ❖ Recognized Chancellor Will Wainwright for receiving the community leadership award from the St. Tammany Parish Chamber of Commerce.
- ❖ Noted that South Louisiana Community College (SLCC) received its first National Science Foundation Grant in the amount of \$225,000 for Process Technology and a second planned gift of \$100,000 for Process Technology.
- ❖ Shared that the Coughlin Saunders Foundation awarded Central Louisiana Technical Community College (CLTCC) \$250,000 to purchase equipment for five program areas: Nursing & Allied Health, Manufacturing, Welding, Electrical Technology, and Drafting & Design Technology.
- ❖ Announced that Entergy will make an exciting announcement at River Parishes Community College this Friday, April 13, 2018. Information regarding this event will be shared with each member.
- ❖ Reminded members that the Delgado Annual Roast of the Town will take place Friday, April 20, 2018. Governor John Bel Edwards will be the guest of honor, and former Governor Edwin Edwards will serve as one of the roasters that evening.
- ❖ Provided a brief update on the legislative budget process. The Revenue Estimating Conference will meet and it is anticipated that they will recognize additional revenue. Dr. Sullivan continues to appear and testify in legislative committees as requested. He shared frustration that the legislature continues to pit higher education against healthcare services. Supervisor Zack Hitt represented LCTCS extremely well recently and reminded members that technical and community college education is fundamental to the growth in the Louisiana economy.

3. Letter of Intent for the transfer of the “Tulane Building” owned by the Louisiana State University Health Science Center New Orleans to the LCTCS on behalf of Delgado Community College

**On motion by Supervisor Carter, seconded by Supervisor Richardson, the Board voted to authorize the President and Chancellor of Delgado Community College to negotiate and execute all documents necessary for the transfer of ownership of the “Tulane Building” and garage, located at 1542 Tulane Avenue, New Orleans, from the LSU Health Science Center of New Orleans (LSUHSCNO) to the LCTCS for the benefit and use by Delgado Community College. The conveyance documents for this transfer must be filed with the local Clerk of Court and the State Land Office. The motion carried.**
