VII. OTHER BUSINESS

Mr. Jim Craft, the Executive Director for the Louisiana Commission on Law Enforcement, was introduced to the Board members.

The Board members discussed the Working Guidelines for Sexual Assault Applications and made the decision to continue using them.

Mr. Wertz gave an update on budget issues.

The Board discussed how to handle juvenile sexual abuse cases that do not include a police report and advised the staff to contact the Louisiana Hotline for the Department of Children and Family Services, then to let the healthcare provider know that DCFS had been notified.

The Board discussed approving the sexual assault cases being sent to CVR directly from the healthcare provider en globo.

The Board discussed writing a functional definition of total and permanent disability and creating a form for medical/mental health professionals to complete when a claimant is requesting eligibility for total and permanent disability. They recommended checking definitions by Worker's Compensation and Social Security.

Ms. Rodi made a motion to allow Mr. Jeddie Smith of the Louisiana Attorney General's office to act on behalf of CVR in dealing with the "L. Jackson" case. Ms. Tonkovich seconded the motion and the motion passed unanimously.

Ms. Sims arrived late and approved en globo all the decisions before she arrived and after she left the meeting.

Ms. Rodi made a motion to adjourn the Board meeting. Mr. DiBenedetto seconded the motion. Ms. Polak adjourned the meeting at 12:15 p.m.
