## VII. OTHER BUSINESS

The Board rescheduled the February Board meeting from February 9, 2016 to February 18, 2016 due to the Mardi Gras holiday.

The Board discussed the Lonnie Jackson case which involves his attorney requesting that the Board waive reimbursement of expenses paid by the Board, because to his lawsuit settlement was not enough to cover his medical expenses. An extension was granted for the Board to respond to that request. Mr. Jackson's attorney requested that discussion be postponed until the next Board meeting. The Board agreed because more documentation from the attorney is forthcoming.

Mr. Wertz discussed the recent updates involving sexual assault cases: Notice of Intent, Policy, Rules. Mr. DiBenedetto made a motion to adopt as emergency rules the information in the Notice of Intent. Ms. Sims seconded the motion and the motion passed unanimously.

Emergency awards were discussed. The Board discussed issuing emergency award for funeral expenses and decided to only pay direct funeral costs expenses such as the funeral home, the cemetery costs and the cost of transporting a body. Any other expenses may be requested on a regular application.

The Board also decided to set a policy that emergency awards would not be issued for undocumented persons except in the cases of domestic violence, sexual assault, and human trafficking.

The Board discussed "Go-Fund-Me" accounts and decided to disregard them since there is no way to know what payments to them are intended for and how much money was actually collected.

Ms. Adcock and Ms. Williams stated that they would be resigning from the Board. The official resignation date is February 1, 2016.
