Vice Chairman Lewis asked for a motion to adopt the newly revised LEBA By-Laws. **Motion:** Pat Regan - To adopt the proposed LEBA By-Laws. Noah Aguillard 2<sup>nd</sup>. Motion carried.

**MARTHA MANUEL, GOEA EXECUTIVE DIRECTOR'S REPORT**

GOEA Executive Director, Martha Manuel, expressed concerns to LEBA board members and attendees of the recent proposal in Governor's Jindal FY13 (July 1 2012–June 30 2013) budget for the Department of Health & Hospitals (DHH) to takeover the Governor's Office of Elderly Affairs. A report of plans for GOEA will be given by a DHH representative today. DHH has made false insinuations and misleading statements regarding the current operations of the Governor's Office of Elderly Affairs. GOEA continues to provide a single point of entry (Adult & Disabled Resource Center/ADRC) to all seniors seeking information on services provided by AAAs and CoAs statewide. As GOEA Executive Director, our office strives to provide an outstanding array of services to the elderly population within our Aging Network.

**LATISHA LEWIS, ACCOUNTANT ADMINISTRATOR & ACCOUNTING & FINANCE**

A Happy Valentine's Day was wished for all attendees. Review of Packet for LEBA Members – 3 documents 1) **Summary of Adjustments From EOB** -- State General Funds (\$22,691,190); Interagency Transfers (\$37,000); Fees & Self Generated Revenues (\$39,420); Statutory Dedications (\$92,374); Federal Funds (\$22,439,527); Total Means of Financing (\$45,300,011); and Table of Organization (56) positions. **The recommended budget for FY2013 is 0.** 2) **Line Item Expenditures** (\$45,300,011) – Breakdown reflects that the bulk of OEA expenditures go to LA's seniors.

**Adjustments to Existing Operating Budget** -- Annualization of FY2012 Mid Year Reduction Plan) (\$56,075); State Employee Retirement Rate Adjustment (\$251,782); Salary Base Adjustment (\$7,439); Attrition Adjustment (\$5,280); Personnel Reductions (4) No indication of positions to be eliminated; Risk Management \$698; Legislative Auditor Fees (\$3,274); Maintenance in State-Owned Buildings \$244; UPS Fees (\$166); Civil Service Fees \$1,008; Non-recurring 27<sup>th</sup> Pay Period (\$108,332); Total Other Adjustments Adjustment (\$164,112); Total Other Technical Adjustment (\$44,705.481) and (52) positions.

**Agency Specific Recommendations:**

\$721,038 **Councils on Aging** – This adjustment provides funds to update the Senior Centers funding formula provided for in R.S.46:1608, using 2010 Official U.S. Census Data.  
(\$1,036,268) **Senior Centers** – This adjustment *eliminates supplemental funding* awarded to all 64 parishes for the support of Senior Centers. This funding is not associated with the Senior Centers funding formula provided in R.S. 46: 1608.  
\$151,118 **Senior Centers** – This adjustment provides funds to update the Parish Councils on Aging funding formula provided in R.S. 46:1606, using 2010 Official U.S. Census Data.

There has been a \$1M cut in Senior Center funding.

**ATTACHMENT NO. 2 (4 Pages)**

The Executive Budget is available on the Commissioner's website.

These figures represent the proposed changes in the FY2013 budget for the Governor's Office of Elderly Affairs. GOEA had no knowledge of the proposed changes in the budget until 11:30 AM last Tuesday, February 7, and its introduction at the Joint Legislative Committee meeting on Thursday, February 9<sup>th</sup>. No meetings have been held to discuss budget changes and the DHH/OAAS transfer with Martha Manuel, LEBA nor any of the AAAs/COA directors. The transferring of the Ombudsman Program to DHH is a violation of the statutory designation 42 USC 3058(G). The first bill was introduced in 2006 to transfer GOEA into DHH/OAAS, but failed in the Legislative Session. The Administration on Aging (AoA) is researching policy for a possible violation of state (RS 46:935 & 936) and federal statutes. A new bill must be introduced in the 2012 Legislative Session to move the Governor's Office of Elderly Affairs to DHH/OAAS before any action can be taken. Numerous attempts have been made by AAA/COA directors to meet with Tammy Woods, Office of the Governor, but each appointment has been cancelled.  
**ATTACHMENT NO. 3 (2 Pages)**

There was an open discussion of the next steps the AAA/COA directors and the LEBA Board should follow to stop this transfer in the 2012 Legislative Session. A suggestion was made to seek an Attorney General's opinion. Once the 2013 budget has been introduced in the Legislative Session, RS 46:1606 and RS 46:1608 have been violated. The next step will be to educate our legislators, listen to today's presentation by Kathy Kliebert, DHH; and find out what DHH's plan is for leveraging the money.

Huey Beverly **Motion:** For GOEA staff to draft a resolution against moving the Governor's Office of Elderly Affairs under the Department of Health & Hospitals, Office of Aging & Adult Services. 2<sup>nd</sup> Van LaCour. Motion carried.

### **SPECIAL GUEST-KATHY KLIEBERT, DHH DEPUTY SECRETARY(11:00 AM)**

A presentation was given by Kathy Kliebert, Deputy Secretary, Department of Health & Hospitals, regarding the proposed move of the Governor's Office of Elderly Affairs from the Office of the Governor to the Department of Health & Hospitals, Office of Aging & Adult Services. This is the first part of this process and a separate piece of legislation must be approved by the legislative process before this transfer can take place. A stakeholder's meeting is scheduled for Thursday, February 16, 2PM, at the DHH building, Room 118. It is an open meeting and everyone is welcome to attend. The proposal is the best way to meet future needs of elderly citizens in this state. The elderly population is currently 18% over 60 years of age, and is expected to increase to around 25% with the influx of the baby boomers within the next 18 years. This proposal does not reduce any funding to AAAs/COAs. It was noted that \$1M has been removed from the 2013 budget for Supplemental Senior Centers on Wednesday, February 8th. COAs/AAAs will have to contract with hospitals and nursing home for funding. This move will provide additional dollars and improve funding for the AAAs/COAs by avoiding duplications; it will provide the elderly with the opportunity to get the services they need; there will be more grant opportunities; and it will provide DHH with the ability to match state dollars and leverage Medicaid dollars. It was noted that AAAs/COAs do not serve Medicaid eligible individuals. Much opposition was given by Board members and AAAs/COAs directors towards DHH's proposal. It was also noted that GOEA or AAAs/COAs have not been a part of the discussion of this proposal. In 2005, the Office of Aging & Adult Services, DHH was formed. The Commission on Streamlining Government in 2009 did not recommend moving GOEA into the Office of Aging & Adult Services, DHH. Two changes have occurred in the last two years noted by Ms. Kliebert that A&AS/DHH was a new office with an administrative structure and it now has the ability to leverage funds at that time. The board thanked Ms. Kliebert for her presentation.

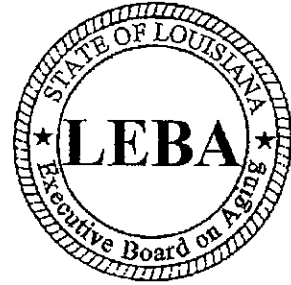

§935. Power of review of proposals of state agencies

A. Any state agency or department proposing to establish, modify, or expand programs or services for the elderly of the state shall consult with the director of the office, who shall consult and coordinate a response with the parish voluntary councils on the aging as appropriate.

B. The office shall review and report upon all such proposals submitted to it and shall comment as to the following:

(1) The relationship and impact of the proposal on existing programs affecting the elderly.

(2) The impact of any proposed legislation, regulation, or order upon the elderly.

(3) Recommendations as to (a) the desirability of the proposal and (b) modifications that would enhance the positive impact of the proposal upon the elderly or aid in the implementation of the proposal.

C. All state agencies administering programs or implementing policies which affect the health or well being of the elderly shall cooperate with the office in carrying out these responsibilities.

Added by Acts 1982, No. 842, §2, eff. Aug. 4, 1982.

§936. Statement of intent

A. It is the intention of the legislature that, insofar as is practical and consistent with the efficient administration of state government, programs and services for the elderly population of Louisiana, with the exception of any programs administered by the Department of Children and Family Services or the Department of Health and Hospitals on August 15, 1995, shall eventually be consolidated within the Office of Elderly Affairs, to be administered at the local level by the sixty-four parish voluntary councils on aging.

B. It is further the intention of the legislature that the Office of Elderly Affairs administer all federal funds appropriated, allocated, or otherwise made available to the state for services to the elderly, whether by block grant or in any other form, with the exception of funds for programs administered by the Department of Children and Family Services or the Department of Health and Hospitals on August 15, 1995. The Office of Elderly Affairs shall distribute such funds in accordance with appropriate state and federal requirements and consistent with this Section.

Acts 1995, No. 1222, §1.

If the Office of Elderly Affairs is eventually incorporated into DHH, it should be done in a constructive manner with statements viewing their agency in a positive light, not based on false statements and innuendoes of ineptness at GOEA.

As members of the LEBA Board I want to make sure that you all understand, there is no truth to these statements.

It has always been my desire to be a team player wherever I have worked. But now the time has come for me to set the record straight.

Here are the facts.

Our State Ombudsman was offered a position at DHH – a position that was created just for her. This happened at the same time we were told we could not fill positions or hire additional people.

Our remaining staff continued to have to take on the additional duties of staff members that left – with no more pay, and no appreciation for the hard work and sacrifices they made to keep our office running smoothly.

GOEA contracts with the Area Agencies on Aging, and works hand in hand with our Councils on Aging to keep people out of nursing homes and hospitals, so they can spend their remaining years wherever they want to, with the dignity and respect they so richly deserve.

View the small GOEA staff, their pay, and the services being provided by the Councils on Aging.

Then, consider what it would take for a large agency like DHH, with their layers of bureaucracy, and high salaries at each level, to provide these same services.
