SEED AND INDUSTRIAL HEMP REGULATION REVISION PROPOSALS

Bahiagrass Seed Certification Standards –

Mr. Cannon provided a summary of the proposed amendments to the Bahiagrass Seed Certification Standards.

Motion to approve regulation changes to §707 Bahiagrass Certification Standards as recommended by LDAF staff was made by Dr. Philip Elzer; seconded by Mr. David Causey. No opposition. Motion passed unanimously.

Tissue Culture Sugarcane Seed Certification Standards –

Mr. Cannon and Dr. Andre Gama provided a summary of the proposed amendments to the Sugarcane Certification Standards.

Motion to approve regulation changes to §763 Sugarcane (Tissue Culture) Certification Standards as recommended by LDAF staff was made by Mr. Gregory Gravois; seconded by Mr. Andy Brown. No opposition. Motion passed unanimously.

Sweet Potato Seed Certification Standards

Mr. Cannon and Dr. Cole Gregorie provided a summary of the proposed amendments to the Sweet Potato Certification Standards.

Motion to approve regulation changes to §755 Sweet Potato Certification Standards (Virus and Non Virus-Tested) as recommended by LDAF staff was made by Mr. David Causey; seconded by Mr. Travis Walker. No opposition. Motion passed unanimously.

Industrial Hemp Seed Certification Standards

Mr. Cannon provided a summary of the proposed Hemp Seed Certification Standards.

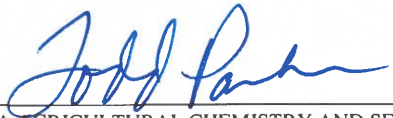
