## **SEED PROGRAMS**

### **Stipulated Cases**

#### **Case No: 23-SEED-0007 Barenbrug USA, Inc**

Barenbrug USA, Inc was charged with nine violations of the Louisiana Seed Law and regulations La R. S. 3:1431 during the fiscal period of July 1, 2022 through June 30, 2023, specifically, one violation of La R.S. 3:1444(2); three violations of LAC 7:301(4)(a); three violations of LAC 7:301(14) and two violations of La. R.S. 3:1436(2)(a).

Ms. Lebra Bias entered exhibits LDAF 1 and LDAF 2 into evidence LDAF 1: charge letter sent via certified mail with signed receipt and seed notices of violation, and LDAF 2: signed, initialed, dated and accepted stipulation agreement between the LDAF and Respondent. Ms. Alicia Wheeler, hearing officer, accepted the evidence as presented.

The Seed Programs Staff recommended a penalty of Two Thousand, Two Hundred and Fifty Dollars (\$2,250.00) for the violations.

**Motion** to accept the stipulation agreement as the findings of facts and conclusions of law, and to accept the recommended penalty of Two Thousand, Two Hundred and Fifty Dollars (\$2,250.00) was made by Mr. Cecil Jones and seconded by Dr. Phil Elzer. Motion passed unanimously. No recusals or abstentions.

#### **Case No: 23-SEED-0008 BWI Companies, Inc**

BWI Companies, Inc was charged with thirty-six violations of the Louisiana Seed Law and regulations La R. S. 3:1431 during the fiscal period of July 1, 2022 through June 30, 2023, specifically, two violations of LAC 7:143(A); ten violations of RS 3:1436(2)(a); two violations of LAC 7:143(B); eight violations of R.S. 3:1444(2); four violations of LAC7:301(14); four violations of R.S. 3:1436(1)(d) and six violations of La. R.S. 3:1444(4).

Ms. Lebra Bias entered exhibits LDAF 1 and LDAF 2 into evidence LDAF 1: charge letter sent via certified mail with signed receipt and seed notices of violation, and LDAF 2: signed, initialed, dated, and accepted stipulation agreement between the LDAF and Respondent. Ms. Alicia Wheeler, hearing officer, accepted the evidence as presented.

The Seed Programs Staff recommended a penalty of Twelve Thousand, Two Hundred and Fifty Dollars (\$12,250.00) for the violations.

**Motion** to accept the stipulation agreement as the findings of facts and conclusions of law, and to accept the recommended penalty of Twelve Thousand, Two Hundred and Fifty Dollars (\$12,250.00) was made by Dr. Phil Elzer and seconded by Mr. David Causey. Motion passed unanimously. No recusals or abstentions.

### **Case 23-SEED-0009 Green Garden Products**

Green Garden Products was charged with thirty-seven violations of the Louisiana Seed Law and regulations La R. S. 3:1431 during the fiscal period of July 1, 2022 through June 30, 2023, specifically, thirty-six violations of La R.S. 3:1436(5)(c); and one violation of LAC 7:301(4)(a).

Ms. Lebra Bias entered exhibits LDAF 1 and LDAF 2 into evidence LDAF 1: charge letter sent via certified mail with signed receipt and seed notices of violation, and LDAF 2: signed, initialed, dated, and accepted stipulation agreement between the LDAF and Respondent. Ms. Alicia Wheeler, hearing officer, accepted the evidence as presented.

The Seed Programs Staff recommended a penalty of Nine Thousand, Seven Hundred and Fifty Dollars (\$9,750.00) for the violations.

**Motion** to accept the stipulation agreement as the findings of facts and conclusions of law, and to accept the recommended penalty of Nine Thousand, Seven Hundred and Fifty Dollars (\$9,750.00) was made by Mr. Ed O'Neal and seconded by Mr. Gregory Gravois. Motion passed unanimously. No recusals or abstentions.

### **Case 23-SEED-0010 Big Lots Stores, LLC 1701**

Big Lots Stores, LLC 1701 was charged with two violations of the Louisiana Seed Law and regulations La R. S. 3:1431, specifically, two violations of LAC 7:301(A)(5).

Ms. Lebra Bias entered exhibits LDAF 1 and LDAF 2 into evidence LDAF 1: charge letter sent via certified mail with signed receipt, and LDAF 2: signed, initialed, dated, and accepted stipulation agreement between the LDAF and Respondent. Ms. Alicia Wheeler, hearing officer, accepted the evidence as presented.

The Seed Programs Staff recommended a penalty of One Thousand Dollars (\$1,000.00) for the violations, with Five Hundred Dollars (\$500.00) of the penalty suspended for a total penalty of Five Hundred Dollars (\$500.00).

**Motion** to accept the stipulation agreement as the findings of facts and conclusions of law, and to accept the recommended reduced penalty of Five Hundred Dollars (\$500.00) was made by Mr. Cecil Jones and seconded by Mr. Travis Walker. Motion passed unanimously. No recusals or abstentions.

### **Case 23-SEED-0011 J & J Bagging**

J & J Bagging was charged with twenty-nine violations of the Louisiana Seed Law and regulations La R. S. 3:1431 during the fiscal period of July 1, 2022 through June 30, 2023, specifically, four violations of La R.S. 3:1444(4); ten violations of LAC 7:143(A); two violations of LAC 7:301(4)(c); six violations of R.S. 3:1444(2); five violations of LAC 7:301(14) and two violations of R.S. 3:1436(2)(a).

Ms. Lebra Bias entered exhibits LDAF 1 and LDAF 2 into evidence LDAF 1: charge letter sent via certified mail with signed receipt and seed notices of violation, and LDAF 2: signed, initialed, dated, and accepted stipulation agreement between the LDAF and Respondent. Ms. Alicia Wheeler, hearing officer, accepted the evidence as presented.

The Seed Programs Staff recommended a penalty of Twelve Thousand, Two Hundred and Fifty Dollars (\$12,250.00) for the violations.

**Motion** to accept the stipulation agreement as the findings of facts and conclusions of law, and to accept the recommended penalty of Twelve Thousand, Two Hundred and Fifty Dollars (\$12,250.00) was made by Mr. David Causey and seconded by Mr. Ed O’Neal. Motion passed unanimously. No recusals or abstentions.

### **Case 23-SEED-0012 Pennington Seed, Inc**

Pennington Seed, Inc was charged with eight violations of the Louisiana Seed Law and regulations of La R. S. 3:1431 during the fiscal period of July 1, 2022 through June 30, 2023, specifically, six violations of LAC 7:143(A); one violation of R.S. 3:1436(1)(d) and one violation of R.S. 3:1444(2).

Ms. Lebra Bias entered exhibits LDAF 1 and LDAF 2 into evidence LDAF 1: charge letter sent via certified mail with signed receipt and seed notices of violation, and LDAF 2: signed, initialed, dated, and accepted stipulation agreement between the LDAF and Respondent. Ms. Alicia Wheeler, hearing officer, accepted the evidence as presented.

The Seed Programs Staff recommended a penalty of Three Thousand, Five Hundred Dollars (\$3,500.00) for the violations.

**Motion** to accept the stipulation agreement as the findings of facts and conclusions of law, and to accept the recommended penalty of Three Thousand, Five Hundred Dollars (\$3,500.00) was made by Dr. Phil Elzer and seconded by Mr. David Causey. Motion passed unanimously. No recusals or abstentions.

### **Case 23-SEED-0013 Bayer Cropscience, LP**

Bayer Cropscience, LP was charged with one hundred eighty-five violations of the Louisiana Seed Law and regulations La R. S. 3:1431 during the fiscal period of July 1, 2022 through June 30, 2023, specifically, one hundred eighty-five violations of LAC 7:143(A).

Ms. Lebra Bias entered exhibits LDAF 1 and LDAF 2 into evidence LDAF 1: charge letter sent via certified mail with signed receipt and seed notices of violation, and LDAF 2: signed, initialed, dated, and accepted stipulation agreement between the LDAF and Respondent. Ms. Alicia Wheeler, hearing officer, accepted the evidence as presented.

The Seed Programs Staff recommended a penalty of Ninety-Two Thousand, Five Hundred Dollars (\$92,500.00) for the violations.

**Motion** to accept the stipulation agreement as the findings of facts and conclusions of law, and to accept the recommended penalty of Ninety-Two Thousand, Five Hundred Dollars (\$92,500.00) was made by Mr. Gregory Gravois and seconded by Mr. Cecil Jones. Motion passed unanimously.

The Adjudicatory Hearing was adjourned at 10:10 am.

## **NEW BUSINESS**

### **SEED PROGRAMS**

#### **Seed Labeling Requirements letter**

Lester Cannon, Director of Seed Programs, shared a letter that was sent to all Louisiana Seed Dealers reminding them of the requirement that the seed label is required to accompany the seed lot to its final

destination. Current agricultural practices often require the repackaging of seed from the original labeled container into bulk or other containers as a means of distribution to the final destination. As a result of that process, many times the seed label is lost and does not get attached to or accompany the repackaged seed shipment.

LDAF provided the guidance, specifically for seed that has been removed from the original labeled container, repackaged after seed treatment or seed enhancement, or placed in bulk seed tenders, seed spreaders or other bulk shipping containers for distribution, as a means for seed dealers to remain compliant with the Louisiana seed labeling requirement.

## **PROGRAM UPDATES**

Lester Cannon announced to the Commission recent staff changes and Commission appointments as follows: Ms. Lebra Bias, as the new LDAF AES attorney, Ms. Shelby Powers as the new Industrial Hemp Administrative Coordinator, Mr. Andy Brown, as new Commission designee for Mr. Jim Harper, LA Farm Bureau Association. He also notified the commission members that David Johnston retired from his position as LDAF Seed Administrative Program Coordinator.

### **Seed and Industrial Hemp Programs Division**

*Seed Program* – Lester Cannon gave an update of seed laboratory sampling and testing data as well as the lab’s participation in the USDA/LDAF Cooperative Agreement Federal Seed Act Enforcement program. He informed them that the Seed Program staff will make the regulatory sample germination test data for cotton, corn and soybeans available on the LDAF website.

*Industrial Hemp Program* – Brent Cutrer gave an update of current calendar year Industrial Hemp data including an update on the Industrial Hemp Promotion Research & Advisory Board.

### **Agricultural Chemistry Programs Divisions**

*Agricultural Chemistry* – Dr. Ted Gauthier gave an update on current Agricultural Chemistry laboratory progress.

*Fertilizer/Lime Program* – Ms. Angelle Pearson and Dr. Greg Olson gave an overview of the Fertilizer/Lime Programs.

### **Animal Health and Feed Services**

*Feed Program* – Dr. Jonathan Roberts provided an update on the Feed Program including an update on the Postive labeling discussion from the May 17, 2023 meeting.
