Executive Director Report

Mr. Kramer presented a draft of the agency's internal Strategic Plan "Charting Our Way to 2026: Navigating the course to a more accessible and responsive FPHSA." Financial Report:

Fiscal Year 2024 (July 1, 2023 through June 30, 2024)

Ms. Sibley disseminated a copy of FPHSA's first FY2024 budget analysis report, as of September 30, that reflected a projected deficit. The Fiscal Department will continue to monitor revenues and expenditures closely as well as work with the Leadership Team to minimize or eliminate the deficit by fiscal year end. Report Attachments: Operating Budget Projected Expenditures vs Projected Revenue; Summary by Means of Financing; Summary by Expenditure Category; and Escrow Budget.

Fiscal Year 2025 (July 1, 2024 through June 30, 2025)

Ms. Sibley disseminated a copy of FPHSA's final FY2025 budget request recap that reflected a slight increase. The increased funding request is not for any new initiatives, but to cover the increased costs in the leases at the Denham Springs Clinic and the residential treatment facilities, in addition to the regular statewide adjustments for salaries, related benefits, market adjustments (formerly merit increases or performance adjustments), and inflation.

Ms. Pellichino made a motion to accept the Financial Report as presented; seconded by Ms. Lentz.

The motion passed unanimously.

Prevention Services Report

Ms. Solar, Prevention Services Supervisor, gave an informational overview of FPHSA Prevention Services to the board. She highlighted the purpose of prevention services, the various prevention programs, and initiatives unique to FPHSA. She disseminated a copy of her presentation to the board, in addition to 2022 Caring Communities Youth Survey (CCYS) results for Livingston, Tangipahoa, and Washington Parish.

Board Business

Board Member Terms

The board discussed that Ms. Keys' governing board term will expire in December 2023 and she will not be eligible for a consecutive term due to term limits.

The board also discussed the Livingston Parish vacancy. There are several prospects interested and FPHSA will be working with the parish officials on filling this vacancy.
