APPROVAL OF PRIOR MINUTES:

Commission Chairman Craft asked for a motion to approve the minutes from the June, 2021 Commission Meeting. Commissioner Green wanted the June, 2021 minutes to reflect proxy was given but Commissioners cast individual votes. Commissioner Blache offered the motion to approve the minutes, which was seconded by Commissioner Skains, and without objection, the minutes of the meetings were approved.

ETHICS OVERVIEW - Recusal from Voting/Discussion:

 DPS Staff Attorney addressed the ethics overview regarding the voting discussion/recusal process and invited questions/concerns from the Commissioners.

Consideration & Voting Items:

- Drug Policy Board Resolution re: Legalization of Recreational Marijuana
 - O District Attorney Warren Montgomery (Washington/St. Tammany Parishes) briefly discussed the resolution which he authored and is presenting to the Drug Policy Board, requiring LHSC to register a vote at the January, 2022 DPB Meeting, on which the LHSC Executive Director sits. D.A. Montgomery responded to questions and comments from Commissioners, after which time, Chairman Craft called for the motion to vote and allow Executive Director Freeman to represent the Commission on the Drug Policy Board, taking a policy position by voting in favor of the resolution to Oppose the Legalization of Marijuana for Recreational Use in Louisiana. Commissioner Skains offered the related motion, seconded by Commissioner Mack, which passed with one vote in opposition.
- Dissolution and Re-establishment of LHSC Executive Committee authorized by R.S. 48:1356
 - Commissioner Chairman Craft informed the Commission of the Re-Established Executive Committee for LHSC which consist of Commissioner Oxley, Blache, Pohlman, Tyson and Snow. Commissioner Skains offered the motion to accept the Re-Established Executive Committee, which was seconded by Commissioner Green, and without objection, the motion passed.

GRANT FUNDING AMENDMENTS & VOTING:

Deputy Director Cummins presented programmatic overviews, emphasis areas/amended project funding recommendations for the following:

 - Formal ballots were submitted and Commission Mack moved to approve the amended project funding recommendations, seconded by Commissioner Pohlman, and with no objection, the amended project funding recommendations for FFY21-22 were approved.

Director Freeman updated the Commission that all of LHSC's audits were closed and findings were corrected, and informed the Commissioners that the recent federal management review (audit) resulted in no findings and issued a commendation to LHSC regarding the diversity outreach efforts and initiatives.
