The Regular Meeting of the State Mineral and Energy Board was held on Wednesday, May 13, 2020, beginning at 9:30 a.m. via Zoom.

# I. CALL TO ORDER

### a) LEASE REVIEW REPORT MAY 13, 2020 (RESOLUTION NOS. 20-05-012 AND 20-03-001)

#### I. GEOLOGICAL AND ENGINEERING STAFF REVIEW

According to the SONRIS database, there are 1,111 active State Leases containing approximately 468,457 acres. Since the last Lease Review Report, the Geological and Engineering Division reviewed 69 leases covering approximately 51,714 acres for lease maintenance and development issues.

#### II. BOARD REVIEW

1. A staff report on State Lease 173, Caddo Pine Island, Caddo Parish, Gemini Explorations Inc. Upon motion of Mr. Arnold, seconded by Ms. Michaud-Dugas, the Board approved the staff report, that Gemini Explorations Inc. had met its obligation to plug and abandon five (5) wells during the year of 2019, any lease development or release obligations on this lease will be deferred until a future date in accordance with Board Resolution No. 20-05-001, and Gemini Explorations Inc. should continue to plug and abandon wells over State Lease 173. **(RESOLUTION NO. 20-05-012)** 

#### III. FORCE MAJEURE

- Biglane Operating Company requested force majeure recognition due to flooding on the Mississippi River affecting State Lease 4778 beginning January 8, 2020. The staff recognized this force majeure event until the August 12, 2020 meeting when the matter will be reconsidered. Upon motion of Mr. Arnold, seconded by Ms. Michaud-Dugas, the Board confirmed recognition of the force majeure event as stated. (RESOLUTION NO. 20-05-001)
- 2. Ark-La-Tex Oil & Gas Report Service requested on behalf of Kepco Operating Inc. force majeure recognition due to flooding in Catahoula Lake affecting State Lease 18951 in LaSalle Parish beginning January 21, 2020. The staff recognized this force majeure event until the August 12, 2020 meeting when the matter will be reconsidered. Upon motion of Mr. Arnold, seconded by Ms. Michaud-Dugas, the Board confirmed recognition of the force majeure event as stated. **(RESOLUTION NO. 20-05-012)**
- 3. Brammer Engineering Inc. requested on behalf of Tensas Delta Exploration LLC recognition of a force majeure condition due to flooding in Catahoula Lake affecting State Leases 4775 & 4945 beginning January 24, 2020. The staff recognized this force majeure event until the August 12, 2020 meeting when the matter will be reconsidered. Upon motion of Mr. Arnold, seconded by Ms. Michaud-Dugas, the Board confirmed recognition of the force majeure event as stated. **(RESOLUTION NO. 20-05-012)**
- 4. White Oak Operating Co LLC requested recognition of a force majeure condition due to flooding in West Lake Verret Field affecting State Lease 346 beginning February 26, 2020. The staff recognized this force majeure event until the August 12, 2020 meeting when the matter will be reconsidered. Upon motion of Mr. Arnold, seconded by Ms. Michaud-Dugas, the Board confirmed recognition of the force majeure event as stated. **(RESOLUTION NO. 20-05-012)**

#### b) NOMINATION AND TRACT REPORT MAY 13, 2020 (RESOLUTION NO. 20-05-002)

The Board heard the report of Mr. Emile Fontenot on Wednesday May 13, 2020 relative to nominations received in the Office of Mineral Resources for the June 10, 2020 and July 8, 2020 Mineral Lease Sales and other matters.

Based upon Staff's recommendation, and on motion of **Mr. Arnold**, duly seconded by **Ms. Michaud-Dugas**, the Board granted authority to Staff to advertise all such tracts that have been received by the Staff of the Office of Mineral Resources as well as any tracts that have been previously advertised and rolled over and otherwise approve the Nomination and Tract Report. **(RESOLUTION NO. 20-05-002)** 

# c) AUDIT REPORT MAY 13, 2020

The first matter on the audit report was the election of the May 2020 gas royalty to be paid on a processed basis at the Discovery Plant at Larose and the Sea Robin Plant at Henry per the terms of the State Texaco Global Settlement Agreement.
