PCF OVERSIGHT BOARD

February 10, 2022

ZOOM TELECONFERENCE

Dr. Christopher Foret, Chairman, convened the meeting of the Patient's Compensation Fund Oversight Board at 5:30 PM on Thursday, February 10, 2022.

Dr. Foret called the meeting to order and asked that the record reflect eight Board members were in attendance and a quorum was present. Dr. Foret then welcomed the guests to the meeting and asked for all present to be introduced.

Dr. Foret asked for the approval of the Act 43 Meeting Compliance Requirement Vote. Dr. Alvarado made a motion to consider two motions: approval of the PCF January 6, 2022, board meeting minutes and the monthly claim approvals; Mr. Guidry seconded the motion. Ms. Woodard then called the roll; all members were unanimous in favor of hearing the motions.

Dr. Foret called for approval of the January 6, 2022, minutes. Dr. Alvarado moved for the minutes to be adopted and Mr. Naquin seconded the motion; by verbal vote, the minutes were adopted with no dissenting votes.

Dr. Foret asked for the financial and budget reports. Ms. Woodard informed the Board the Fund balance for the fiscal year to date was approximately \$1,270,145,640, the total net collected in surcharge payments to date was approximately \$95,864,391 and the total net filing fees collected to date were \$112,805. She advised the investment income through November was approximately \$23,391,129, the total operating expenses to date were \$3,793,465 and the claims expenses to date were \$48,191,829.

Dr. Foret called for the claims report. Mr. Loup informed the Board for the month of January there were 59 panels filed, 93 panels closed, 71 claims opened, and 71 claims closed, ending the month with a total pending claim count of 3985. Mr. Loup advised \$0 in judicial interest was paid for the month and \$156,120 in legal fees and expenses were paid. Mr. Loup presented 24 claims for settlement approval for the month in the amount of \$10,540,000. There were no questions asked and no public comments made.

Dr. Foret thanked the guests for attending the meeting. Dr. Alvarado then made a motion for the Board to move into Executive Session; Mr. Guidry seconded the motion. The verbal vote was unanimous, and the Board moved into Executive Session to discuss matters of litigation.

After discussion in closed session, Mr. Naquin made a motion to end the executive session and move into open session and to approve the claims with the noted abstentions; Mr. Ruel seconded the motion, and by unanimous verbal vote the motion was approved.

At that time, with no further matters to be discussed, Dr. Alvarado moved for adjournment; Mr. Ruel seconded the motion. By verbal vote, the motion carried with no dissenting votes; the meeting was adjourned at 6:00 pm.
