I. Welcome and Introductions

Honorable Ricky Babin, Chairman

Honorable Ricky Babin, Chairman, welcomed special guest Senator Troy Brown.

II. Approval of Minutes

Honorable Ricky Babin

Motion by Honorable Mrs. Angela Whittaker; seconded by Mr. John DiGuilio. No objections.

Honorable Ricky Babin, Chairman, motioned to reorganize meeting agenda to take Front End and Release Mechanisms Committee reports first. The motion passed without objection.

# III. Reports and Proposed Recommendation of Committees

A. Front End Committee

1. Veteran's Court (Team 2; Group 3)

Carla Sigler ADA, Calcasieu Parish

The problems suffered by veterans often differ in nature and severity from those of other offenders within the criminal justice system. Veteran's Court operates like existing Drug and DWI Courts. The legislation will be placed under Title 13. This legislation includes the following parts: LSA-R.S. 13:5308 – purpose; LSA-R.S. 13:5309 – goals; LSA-R.S. 13:5310 – definitions; LSA-R.S. 13:5311-operation, which offenders can participate; and LSA-R.S. 13:5312 - veteran indicator documents based on federal definition

2. Marijuana Statutes (Team 2; Group 1)

Greg Thompson (Private Attorney, New Orleans)

Analysis of HB-14 shows the proposal would reduce the maximum jail term for 2nd offenses from 5 to 2 years and the fine from \$2,000.00 to \$500.00, as well as reduce the maximum jail term for 3rd offenses from 20 to 5 years and the fine from \$5,000.00 to \$2,000.00. The proposal would create a fourth offense punishable by up to 8 years imprisonment with a fine of up to \$2,000.00. Analysis of other state statutes indicates that neither Florida, Georgia, Kentucky, Mississippi, North Carolina, South Carolina, Texas, nor Virginia provide felony sentence enhancements for subsequent simple possession offenses.

Cost Savings – The total cost for incarcerating and supervising Simple Possession of Marijuana Offenders for FY 2012-13: \$19,828,839. HB-14 purports to save 1.6 million dollars this year and an additional 8.1 million dollars over subsequent years.

Public Safety – Analysis showed only 17.5% were sentenced pursuant to Louisiana's habitual offender statute; 76.1 % are incarcerated solely for drug offenses; and only a combined 5.7% are also serving sentences for violent and sex offenses

A majority of Louisiana citizens support reducing all simple marijuana possession offenses to a fine without jail time.

# B. Re-Entry Evidence Based Corrections

Mr. Rhett Covington

1. Re-Entry/Specialty Courts - Honorable Laurie White

Moving forward with policies and procedures with the cooperation of the DOC, Probation officers, and Courts to see how to best serve Lafayette and Jefferson Parish

- 2. Education not met, Kim Barnette trained in administration of Hi-Set which will offset cost of test
- 3. Substance Abuse- contacted Judge Knight 2/19/14 to use ACT 389 provide services to offenders
- 4. Transitional Work Programs
- 5. Housing currently defunded, looking for other ways to resolve problem
- 6. Social Support still preparing best practices mentoring and peer support (not train better criminals)

### C. Release Mechanisms

Honorable Hans Liljeberg

The following prefiled legislation were reviewed by the Release Mechanisms Committee, and no serious issues identified.

- 1. HB 16 Authorizes the 15th JDC to provide for a reentry division of court. Authored by Rep. Terry Landry
- 2. HB 18 Repeals the statutory authorization for DPS&C to conduct certain pilot programs involving alternative methods of incarceration and electronic monitoring Authored by Rep. Joseph Lopinto"
- 3. HB 55 Revises provisions of law regarding expungement Authored by Rep. Lopinto, Armes, Wesley Bishop, Dixon, Gaines, Honore, Katrina Jackson, Jefferson, Moreno, Jim Morris, and Smith and Senators Gallot, Martiny, Mills, and Morrell
- HB 130 Removes convictions for offenses involving marijuana, tetrahydrocannabinol or chemical derivatives thereof, or synthetic cannabinoids from the habitual offender law. Authored by Rep. Honore
- 5. HB 210 Amends eligibility criteria for medical parole. Authored by Rep. Jefferson

# IV. Presentation on OWI proposal

Honorable Doug Saloom

Honorable Doug Saloom presented a proposal for changes to DWI laws

- adds the present law crime of third degree feticide to the list of crimes constituting a prior conviction.
- changes the requirement of community service from four eight-hour days to 32 hours. Proposed law also adds
  the requirement of participation in a court approved substance abuse program, which may include an
  assessment to determine if the offender has a substance abuse disorder. Proposed law further provides that
  the court may require an ignition interlock device be installed on the offender's vehicle.
- Proposed law requires a minimum of 15 days in jail rather than a fixed period of 15 days in jail as provided for
  by present law. Proposed law provides that the total period of imprisonment for first offense DWI, including
  imprisonment for default in payment of a fine or costs, cannot exceed six months. Proposed law further
  provides that the substance abuse program provided for by present law may include assessment to determine if
  the offender has a substance abuse disorder. Proposed law further provides that the court is to require an
  ignition interlock device be installed on the offender's vehicle for at least six months.
- clarifies that the defendant convicted of a second offense within one year of the first offense is also to be fined \$1,000.
- adds the present law crime of third degree feticide to the list of crimes resulting in an enhanced sentence for second offense DWI. Proposed law adds that the substance abuse program provided for by present law may include an assessment to determine if the offender has a substance abuse disorder. Proposed law also adds that an offender placed on probation must be placed in a home incarceration program for at least six months.
- Proposed law provides that if the offender convicted of a third offense DWI has previously received the benefit
  of parole, probation, or suspension of sentence, then on a subsequent conviction the offender is to be fined
  \$2,000 and imprisoned at hard labor for between two and five years. Proposed law further provides that at least
  two years of the sentence must be served without benefit of parole, probation, or suspension of sentence.
   Proposed law further provides that such offender cannot be sentenced to home incarceration unless certain
  proposed law conditions are met.
- adds that the mandatory minimum sentence of two years for fourth offense DWI cannot be served on home incarceration.
- adds that the offender is not to be eligible to have the mandatory portion of his sentence suspended because of his participation in a drug division program.
- provides that if the offender has previously been required to participate in substance abuse treatment or home
  incarceration pursuant to a sentence imposed on a conviction of a third offense DWI violation, then on a
  conviction of a fourth or subsequent offense the offender is to be imprisoned at hard labor for not less than ten
  nor more than 30 years, at least five years of which are to be imposed without benefit of parole, probation, or
  suspension of sentence, and a \$5000 fine.

- 2. **HB 103 by Representatives Foil and Edwards** increase the sentence for all schedule I asterisked drugs (narcotics-specifically heroin)

  - Recommend excluding "synthetic cannabinoids" and limiting to "simple possession"; Opposed by Honorable Ricky Babin, Chairman, and Honorable Louis Daniel. Motion passes
- 4. **HB "A" by Representative Moreno** increase membership Sentencing Commission by three to specifically address iuvenile justice issues
  - Motion by Honorable Ricky Wicker, seconded by Honorable Laurie White; No opposition; Motion passes
- 5. HB 55 by Representatives Lopinto, Armes, Wesley Bishop, Dixon, Jefferson, Moreno, Jim Morris, and Smith and Senators Gallot, Martiny, Mills and Morrell Expungement

- HB 150 by Representative Gislair creates the misdemeanor crime of "involuntary vehicular homicide"

- 7. SB 55 by Senator Kostelka vehicular homicide when the offender's blood alcohol level exceeds .20 to crimes of violence
  - Recommend to send to committee for 1 year study. Motioned by Honorable Ricky Wicker, seconded by Honorable Hans Liljeberg; No opposition; Motion passes
- 8. SB 63 by Senator Morrell misdemeanor crime of "solar tax credit fraud".
