- 1. Call to Order. The meeting was called to order at 9:15am by W. Lloyd Grafton, Interim Chairman.
- 2. Roll Call. Ms. Derbonne called the roll. Only three Members were present, which did not constitute a quorum. Due to a lack of quorum, no official business could be conducted by the State Police Commission. Individuals present and wishing to address Commission members present were allowed to do so. The Commission Scribe took notes.

- 4. Minutes from the April 14, 2016 meeting. Not having a quorum, W. Lloyd Grafton states the April 14, 2016 minutes will be considered at the next board meeting.

**5. Opportunity to Address the Commission:** Retired State Trooper Leon Millet inquired as to the status of the investigation per docket no. 221-I, whether the Commission was prepared to name respondents, and whether any time limits were an issue.

SPC referee, Taylor Townsend, reported that the preliminary investigation per docket no. 221-I, though still ongoing, has yielded the identity of several individuals who could potentially be named "Respondents," but that the final decision would be made by the Commission. Townsend further explained that the lack of quorum at the April and May meetings.
