11. Consider permit request from Wilcox seeking permission to drill an oil well within 1500 feet of the Red River Backwater Levee in Concordia Parish. (Subject to USACE and DOTD approval)
12. Consider permit request from Greentree Investments seeking permission construct a ramp on the Mainline Mississippi River Levee in Concordia Parish. (Subject to USACE and DOTD approval)
13. Consider permit request from C.T. McCraw & Co., Inc. seeking permission to cross the Backline Levee with a 21" pipe near Clayton in Concordia Parish. (Subject to USACE and DOTD approval)
