# 1. Landscaping and Site Improvements, New Orleans Jazz Museum at the Old U.S. Mint, New Orleans, Louisiana, Project No. 06-263-07B-03, F.06002232.

The project consists of improvements to the 74,700 s.f. grounds of the New Orleans Jazz Museum at the Old U.S. Mint. Additionally, it involves establishing limited utility infrastructure for vendors in a 1,600 s.f. space designated for future tenant buildout within the facility. The scope of work encompasses the creation of a stage area, inclusive of a viewing space, complete with necessary foundations and utility provisions to accommodate a pre-manufactured performance stage. Furthermore, the project involves specifying and providing a covered, pre-manufactured performance stage, establishing a sculpture garden with foundational support for sculptures, an entrance gateway, monumental signage and configuring an exterior seating area tailored for dining and events. Electrical power distribution is a crucial aspect of the project, with provisions for accent lighting throughout the grounds, vendor power requirements in the 1,600 s.f. tenant buildout space and performance/lighting power for the pre-manufactured stage. Specific landscaping improvements include, but are not limited to, the installation of new planters, hardscape features and vegetation. Adjustments and extensions to existing irrigation systems are required to be incorporated as necessary to ensure seamless operation, with rerouting to accommodate new elements. To address the project's complexity, the selected Designer is required to engage structural and electrical engineers, along with stage and acoustic design consultants. The funding for this project is sourced from an EDA (U.S. Economic Development Administration) Grant, necessitating adherence to EDA grant requirements by the chosen firm. The Designer shall prepare and submit all required drawings to Facility Planning & Control in AutoCAD and hard copy. Drawings shall follow the format specified in the "Instructions to Designers for AutoCAD Drawings Submittal". The available funds for construction (AFC) are approximately \$1,000,000.00 with a fee of approximately \$80,566.00. Contract design time is 240 consecutive calendar days; including 80 days review time. Thereafter, liquidated damages in the amount of \$125.00 per day will be assessed. ## 2. Landscaping and Site Improvements, Central Louisiana Supports and Services Center, Alexandria, Louisiana, Project No. 09-340-19-04, F.09000093.

The project consists of landscaping and site enhancements at the Central Louisiana Supports and Services Center. The scope of work encompasses various components, including but not limited to, the strategic planting of trees in both residential and administration areas, the replacement of existing fencing, the addition of facility entrance signage and the establishment of walking paths complete with associated site amenities. Moreover, the project aims to create 10-15 new parking spaces within the residential area, addressing the current needs of the facility. Site utilities exist. The location of and design considerations for the extension of utilities fall under the purview of the Designer. Additionally, the Designer is tasked with making necessary adjustments to and extending existing irrigation systems to ensure seamless operation and proper routing to accommodate the introduction of new landscaping elements. This comprehensive approach is integral to the overall success of the project, ensuring a harmonious blend of aesthetics and functionality. The Designer shall prepare and submit all required drawings to Facility Planning & Control in AutoCAD and hard copy. Drawings shall follow the format specified in the "Instructions to Designers for AutoCAD Drawings Submittal". The available funds for construction (AFC) are approximately \$925,000.00 with a fee of approximately \$75,011.00. Contract design time is 180 consecutive calendar days; including 60 days review time. Thereafter, liquidated damages in the amount of \$125.00 per day will be assessed. Applicants are advised that design time ends when the Documents are "complete, coordinated and **ready for bid**" as stated in to Article 3.3.1 (4) of the Capital Improvements Projects Procedure Manual for Design and Construction. Documents will be considered to be "complete, coordinated and ready for bid" only if the advertisement for bid can be issued with no further corrections to the Documents. Design time will not necessarily end at the receipt of the initial Construction Documents Phase submittal by Facility Planning and Control. Any re-submittals required to complete the documents will be included in the design time.

In addition to the statutory requirements, professional liability insurance covering the work involved will be required in an amount specified in the following schedule. This will be required at the time the Designer's contract is signed. Proof of coverage will be required at that time.
