Local Government Units - Elections (April 29, 2023)

3. **L23-029 - Acadia Parish Police Jury**
(1) 1.5 mills tax, 10 years, 2025-2034, services to the elderly, including the establishment and maintenance of centers for senior citizens; (2) 4.25 mills tax, 10 years, 2025-2034, improving, maintaining, and operating public libraries.
4. **L23-030 - Beauregard Parish, Fire Protection District No. 1**
5.98 mills tax, 10 years, 2024-2033, (1) constructing, acquiring, improving, maintaining and operating fire protection facilities and equipment, (2) paying the cost of obtaining water for fire protection purposes, including tankers and fire trucks and (3) paying the cost of charges for fire hydrant rentals and service.
5. **L23-034 - Concordia Parish Police Jury**
(1) Rededicate (a) \$1,600,000 proceeds heretofore collected for the purposes of acquiring, constructing, maintaining and supporting public roads and drainage, including equipment, animal welfare, and public buildings and (b) any proceeds of the 1.81 mills tax hereafter collected remaining after use for public health purposes, to be used for the rededicated purposes; (2) 3.0 mills tax, 10 years, 2023-2032, providing funding and support for the Coroner's office, including operating and maintaining facilities and equipment.
6. **L23-054 - Desoto Parish, Fire Protection District No. 8**
12.16 mills tax, 10 years, 2025-2034, acquiring, constructing, improving, maintaining, and/or operating fire protection and emergency medical service facilities, vehicles and equipment, including both moveable and immovable property, to provide fire protection and emergency medical services.
7. **L23-043 - Iberia Parish School Board, Parishwide School District**
Not exceeding \$62,500,000 General Obligation Bonds, not exceeding 7%, not exceeding 20 years, capital expenditures, including constructing, acquiring and/or improving schools and other school related facilities, together with equipment and furnishings therefor, including, to the extent feasible, those specific school projects set forth in the "Capital Improvement Plan" approved by the School Board on February 15, 2023.
8. **L23-056 - Orleans Parish Law Enforcement District**
5.5 mills tax, 10 years, 2024-2033, providing additional funding to the Parish Sheriff's Office, including, but not limited to, payment of salaries, equipment and training.
9. **L23-055 - Rapides Parish, City of Alexandria**
11.51 mills tax, 20 years, 2028-2047, constructing, acquiring and improving capital improvement projects, including but not limited to: Sugarhouse Road, Riverfront and Downtown Capital Projects, Ruston Foundry Redevelopment, City-Owned Infrastructure Improvements, Residential Ditch Closures, Street Improvements & Repairs, Parks and Recreation Improvements.

10. L23-025 - Red River Parish School Board, School District No. 1

(1) 16.95 mills tax, 10 years, 2024-2033, additional support for the maintenance and operation of schools; (2) 16.80 mills tax, 10 years, 2024-2033, additional support for paying salaries and benefits.

11. L23-032 - St. John the Baptist Parish School Board, School District No. 1

10.56 mills tax, 10 years, 2024-2033, providing annual improvement of salaries (including employee health care) of teachers and all other employees of the District.
