TAB 3 - LOCAL GOVERNMENTAL UNITS - ELECTIONS (November 16, 2013)

3. **L13-337 - Calcasieu Parish School Board, School District No. 34** - 5 mills tax, 10 years, 2014-2023, (1) acquiring, maintaining and/or improving lands for building sites and playgrounds; (2) purchasing, erecting, enlarging and/or improving school buildings and other school related facilities; (3) acquiring the necessary equipment and furnishings.
4. **L13-351 - Calcasieu Parish, Fire Protection District No. 1, Ward 5** - 6 mills, 10 years, 2015-2024, (1) acquiring, constructing, improving, maintaining and operating fire protection facilities, including equipment and fire protection apparatus and accessories, (2) paying the cost of obtaining water, including charges for fire hydrant rentals, (3) payment of a per diem to firemen for training and attending fires, (4) reimbursement of expenses and paying for services.
5. **L13-352 - Calcasieu Parish, Waterworks District No. 7, Wards 4 and 6** - 6 mills tax, 10 years, 2015-2024, acquiring, constructing, improving, maintaining or operating waterworks facilities.
6. **L13-336 - Calcasieu Parish School Board, School District No. 30** - Not exceeding \$8,000,000 (General Obligation Bonds), not exceeding 8%, not exceeding 20 years; (1) renovating and improving the football stadium and related athletic facilities at Sulphur High School and acquiring the necessary equipment and furnishings; (2) acquiring and/or improving lands for building sites and playgrounds; (3) purchasing, erecting, enlarging and/or improving school buildings and other school related facilities.
7. **L13-335 - Cameron School Board** - (1) 8.50 mills tax, 10 years, 2014-2023, maintaining and operating public schools (2) 6.00 mills tax, 10 years, 2014-2023, improving and maintaining school houses and the public school system. **WITHDRAWN BEFORE MTG**
8. **L13-345 - Morehouse Parish, City of Bastrop, Sales Tax District No. 1** - 0.50% sales tax, 10 years, beginning January 1, 2015, (1) maintaining, improving, repairing and extending the streets, sidewalks, alleys, roadways and related drainage and (2) funding into bonds for capital purposes.
9. **L13-350 - Orleans Parish, City of New Orleans, Twinbrook Security District** - Not to exceed \$575 annual parcel fee, 8 years, 2015-2022, promote and encourage security as determined and managed by the Board of Commissioners of the District.
10. **L13-344 - Ouachita Parish, City of Monroe** - (1) 1.88 mills tax, 10 years, 2014-2023, maintaining and operating the recreational facilities; (2) 1.06 mills tax, 10 years, 2014-2023, (a) providing municipal public safety services and (b) maintaining and operating municipal service departments, including acquisition of necessary equipment; (3) 1.31 mills tax, 10 years, 2014-2023, operating and maintaining drainage facilities; (4) Amend Article VII, Section 7-04 of the Home Rule Charter by adding Section 2-01 G. to provide for term limits of the City Councilmen; (5) Amend Article VII, Section 7-04 of the Home Rule Charter by adding Section 3-03 C. to provide for term limits of the Mayor.

15. **L13-321 - St. Mary Parish Law Enforcement District** - Not exceeding \$1,500,000 Revenue Anticipation Notes, Series 2013, not exceeding 6%, mature no later than June 30, 2014, current expenses.
16. **L13-325 - Tangipahoa Parish Law Enforcement District** - Not exceeding \$3,000,000 Promissory Notes, not exceeding 6%, mature no later than June 30, 2014, current expenses.
17. **L13-327 - West Carroll Parish Police Jury** - Not exceeding \$1,534,000 Letter of Credit, not exceeding 6%, not exceeding 1 year, (1) satisfying DEQ's financial assurance requirements for the payment of closure costs for the Landfill and (2) incur debt to the extent that funds are drawn from said Letter of Credit.

22. **L13-346 - East Carroll Parish, Town of Lake Providence (DEQ Project)** - Not exceeding \$650,000 Taxable Sewer Revenue Bonds, Series 2013, non-interest bearing, not exceeding 20 years, acquiring, constructing and installing improvements, extensions and additions to the wastewater collection, treatment and disposal system.
23. **L13-341 - Iberia Parish Council, Economic Development District No. 1** - Not exceeding \$10,000,000 Sales Tax Bonds, in one or more series, not exceeding 6%, not exceeding 20 years, various capital improvements.
24. **L13-342 - St. James Parish Council** - Not exceeding \$3,000,000 General Obligation Refunding Bonds, not exceeding 4%, mature no later than March 1, 2024, refunding all or any portion of General Obligation Bonds, Series 2005.
25. **L13-328 - St. Landry Parish, Town of Port Barre** - Not exceeding \$540,000 Utilities Revenue Refunding Bonds, Series 2013, not exceeding 3.25%, not exceeding 10 years, refunding Sewer Revenue Bonds, dated July 1, 1998.
26. **L13-329 - Union Parish, Hospital Service District No. 1, Wards 3, 4 and 10** - Not exceeding \$2,000,000 Hospital Revenue and Refunding Bonds, not exceeding 5%, not exceeding 20 years; **(1)** Not exceeding \$1,545,000 Revenue Bonds, improve and renovate the Reeves Medical Center, including equipment, accessories and furnishings and **(2)** Not exceeding \$455,000 Refunding Bonds, refunding Hospital Revenue Bonds, Series 2002.
